Withdrawal Order

WHEREAS Recognition/Permission was granted to the **INDIRA PRIYADARSHINI COLLEGE, V.I.P. ROAD KHANUGAON KHO-E-FIZA BHOPAL 462032 MADHYA PRADESH** under section 14 of NCTE Act, 1993 for conducting **B.P.ED(CO.ED)** physical course with an intake of **50** from the academic session **2006-07**.

2. WHEREAS on the direction of the NCTE headquarters, New Delhi to WRC to conduct the inspection to the institutions u/s 17 of the NCTE Act 1993 and in compliance with the said direction the Western Regional Committee constituted a Visiting Team u/s 17 of NCTE Act, 1993 to Visit the institution. Accordingly the inspection of the institution was conducted.

3. AND WHEREAS, the matter was considered by the WRC in its **107th meeting** of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. Land is inadequate
2. Building plan is not approved by competent authority.

4. AND WHEREAS the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before Withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 28/02/2009.

5. AND WHEREAS the matter was again considered by the Committee in its **116th meeting** held on **3-5 April, 2009** and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting **B.P.ED(CO.ED)** physical course for the next academic session.

6. Now, therefore recognition of the Institution **INDIRA PRIYADARSHINI COLLEGE, V.I.P. ROAD KHANUGAON KHO-E-FIZA BHOPAL 462032 MADHYA PRADESH** in terms of section 17(1) of the NCTE Act, 1993 is hereby Withdrawal from next academic session on the following grounds.

1. The total built up area required for running B.Ed., M.Ed., B.P.Ed. & M.P.Ed. is 4900 sq. mts.
2. The approved building plan and the reply submitted show the total area of 3000 sq. mts. only which is highly inadequate as per NCTE norms.

8. Affiliating Body/ State Govt. are advises not to admit/ allot any student in **B.P.ED(CO.ED)** physical in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.
