#### **ORDER**

WHEREAS, recognition was granted to the institution namely, SHRI NASHIKRAO TIRPUDE COLLEGE OF PHYSICAL EDUCATION, SADAR CIVIL LINES, NAGPUR, MAHARASHTRA (WRC/OAPW0194/114059) under section 14 of NCTE Act. 1993 for conducting B.P.ED. course vide order dated 14.12.2000 for an annual intake of 80 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institutions and the reply was received on 09.02.2015.

AND, WHEREAS, Revised Recognition order was issued for basic unit of 100 (one hundred) students with two sections of 50 (fifty) each to the institution on 31.05.2015.

AND, WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...Follow up of Revised Orders for B.P.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 03.10.2016 and reply submitted by the institution on 21.10.2016.

AND WHEREAS, the reply was placed in 292<sup>nd</sup> Meeting held on May 15-17, 2018 of WRC and the Committee decided that "...Consequent to the issue of Revised Recognition order, Show Cause Notice dated 03.10.2016 was issued for non-compliance.

The institution vide reply dated 15.10.2016 has submitted the staff profile as per Appendix-VII of NCTE Regulations, 2014 but it is not approved by the Registrar and not in original.

FDRs for additional Rs.4.00 lakhs in joint account and Building Completion Certificate issued by a Government Engineer not submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the Clarification/Compliance letter issued on 31.05.2018 and reply submitted by the institution on 11.06.2018, 20.08.2018 and 24.08.2018.

AND WHEREAS, the reply was placed in 297<sup>nd</sup> Meeting held on September 13-14, 2018 of WRC and the Committee decided that "...Consequent to the issue of Revised Recognition order, Show Cause Notice dated 03.10.2016 followed by a compliance letter dated 31.05.2018 were issued.

The institution replied on various dates, the last being 24.08.2018. The institution has submitted staff profile approved by the Registrar and FDRs for Rs.12.00 lakhs. It has also submitted Building Completion Certificate.

Hence, the institution is permitted to continue for one unit of 100 seats."
