Reference decision taken by WRC, NCTE in its 359th meeting held on 18th April, 2022, accordingly Recognition Order was issued vide F.No. WRC/RJ./B.ED.(ADDITIONAL)/359thMEETING/2022/220219 to 220226 dated 08.09.2022 in respect of institution viz. Salasar Balaji B.Ed. College, Plot /Khasra No. 555, Behind Circuit House, Jaipur Road, P.O. Sikar, Tehsil-Sikar, Dist.- Sikar, Rajasthan, Pin Code- 332001 for conducting B.Ed. (Additional Intake 2 units) course inadvertently mentioning annual intake of 50 students from the academic session 2023-2024.

Subsequently, the matter was considered by WRC in its 372nd (Emergent) Meeting held on 30th September, 2022 and the Committee decided as under:

"In compliance of Order dated 23.09.2022 passed in WP (Civil) No.500/2022 titled Salasar Balaji B.Ed. College and Anr. Vs NCTE and others by Hon'ble Supreme Court of India, the academic session mentioned in the recognition order in respect of institution viz. Salasar Balaji B.Ed. College, Plot /Khasra No. 555, Behind Circuit House, Jaipur Road, P.O. Sikar, Tehsil-Sikar, Dist.- Sikar, Rajasthan, Pin Code-332001 for B.Ed. course be changed as 2022-2023 instead of 2023-2024."

In view of the above, the para 1, 2 & 3 of recognition order dated 08.09.2022 issued by WRC, NCTE is hereby rectified as under:

"Whereas, in terms of Section 14/15(1) of the NCTE Act, 1993, Gurukul Shikshan Sansthan, Opposite Shiv Mandir Cinema, Fatehpur Road, Sikar-332001, Rajasthan had submitted an application to the Northern Regional Committee (now Western Regional Committee) of the NCTE for grant of recognition/permission to institution viz. Salasar Balaji B.Ed. College, Plot/Khasra No. 555, Behind Circuit House, Jaipur Road, P.O. Sikar, Tehsil-Sikar, Dist.- Sikar, Rajasthan, Pin Code-332001 for B.Ed. (Addl. Intake) course.

2. And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the WRC in its 359th meeting held on 18th April, 2022 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. Now therefore, in exercise of the powers vested under Section 14/15 (3) (a) of the NCTE Act, 1993 and in accordance with the NCTE Regulations, 2014, the Western Regional Committee, NCTE hereby grants permission for conducting B.Ed. course with an additional annual intake of 100 students (two units), thus making the total intake of 200 from the academic session 2022-2023 to Salasar Balaji B.Ed. College, Plot /Khasra No. 555, Behind Circuit House, Jaipur Road, P.O. Sikar, Tehsil-Sikar, Dist.- Sikar, Rajasthan, Pin Code-332001. The institution is required to ensure about the availability of the regular staff for teaching B.Ed. course with total intake capacity of 200 (four basic units)."

The other contents of the recognition order dated 08.09.2022 shall remain unchanged.
