#### WITHDRAWAL ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely **SMT RUKMA DEVI MAHILA SHIKSHAN PRASHIKSHAN MAHAVIDYALAYA, VEER DURGA DAS NAGAR, PALI, RAJASTHAN** vide order No. NRC/NCTE/F-7/RJ-623/7798-807 dated 08.11.2006 for conducting **B.ED**. course with an annual intake of 100 students in a rented premises with a condition to shift to its own premises within three years of such recognition.

2. The matter was considered by WRC in its 316<sup>th</sup> meeting of WRC held on 27<sup>th</sup> – 28<sup>th</sup> and 4<sup>TH</sup> August 2020 wherein the committee decided as under: -

The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision.

- 3. **Accordingly**, the Show Cause Notice was issued to the institution vide dated **27.09.2020**, and the institution has not submitted the reply of the above Show Cause Notice.
- 4. AND WHEREAS, the matter was considered by WRC in its 321st meeting of WRC held on 09th to 11th November 2020, wherein the committee decided as under: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

- 1. Recognition was granted to the institution on 07.11.2006 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
- 2. The institution has not shifted the institution in its own premises till date.
- 3. Accordingly, Show Cause Noted was issued to the institution on 27.09.2020.
- 4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-22."

- 5. AND WHEREAS, as per the decision of WRC, the Withdrawal order for B.Ed course dated 14<sup>th</sup> December 2020 was issued to the institution.
- 6. AND WHEREAS, the institution preferred an Appeal against the decision of WRC and the Appellate authority vide order dated 02<sup>nd</sup> June 2021 has remanded the case to WRC with a direction to consider the reply of the appellant institution which is required to sent again by the appellant to WRC within 15 days of the issue of the appeal order.
- 7. The institution did not submit any reply.
- 8. AND WHEREAS, the matter was considered by WRC in its 339<sup>th</sup> meeting held on 28<sup>th</sup>- 30<sup>th</sup> July 2021 and the WRC decided as under :-

This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC noted that as per the order of the Appellate authority the institution was required to submit their reply to Show Cause notice within 15 days, however, till date the institution has not submitted the reply to WRC.

In view of the above, the Committee decided that the decision for withdrawal taken by WRC and intimated to the institution vide dated 14<sup>th</sup> December 2020 stands.

- 9. NOW, THEREFORE, as per the decision of WRC in 339<sup>th</sup> meeting, the institution is hereby informed that the withdrawal order issued by WRC vide dated 14<sup>th</sup> December 2020 stands.
- 10. **Further,** if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
