ORDER FOR CHANGE OF NAME OF INSTITUTION

Date: 12 7 25

WHEREAS, the institution namely, Madhav Mahavidyalaya, Vivekanand Marg, Lashkar, Gwalior, Madhya Pradesh was granted recognition by WRC NCTE for B.Ed. Course of one year duration with an annual intake of 100 students vide order No. WRC/2-32/223240/75/2005/5757 dated 21.07.2005 followed by formal recognition order No.WRC/5-32/F.O/2006/C-19124 dated 10.07.2007 for B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, revised order was issued to the institution vide No.WRC/APW01442/223240/75/2015/142110 dated 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 subject to compliance of conditions mentioned therein.
- 3. **AND WHEREAS**, in its 287th meeting of WRC held on 30-31 January, 2018, the Committee noted that as per staff profile of 1+8 submitted by the institution, it is sufficient for one unit intake and institution has to submit the Building Completion Certificate and FDR of Rs.5.00 lakhs. Accordingly, clarification letter dated 01.02.2018 was issued to the institution.
- 4. **AND WHEREAS**, institution submitted reply vide letter dated 22.02.218 in response to clarification letter received on 23.02.2018, wherein given its consent to run 50 intake (one unit) of B.Ed. course due to difficulties to run two units and the matter was considered by WRC in its 290th meeting held on 21-23 March, 2018, wherein the Committee decided that letter for reduced intake will be issued as soon as the institution submits the FDR of Rs.5.00 lakhs. Accordingly, decision was communicated vide letter dated 26.03.2018 to the institution as well as to Dept. of Higher Education, Govt. of Madhya Pradesh vide letter dated 29.06.2018. The original FDR of Rs.5.00 lakh along with Form 'A' issued by bank submitted by the institution vide letter dated 17.09.2018.
- 5. **AND WHEREAS**, in its 298th meeting of WRC held on 09th October, 2018, the Committee decided that the institution is required to submit the list of students admitted in B.Ed. course in the academic session 2018-2019 certified by allotment authority of affiliating body within one month of issue of letter. Accordingly, letter dated 26.10.2018 was issued to the institution and in response, reply vide letter dated 01.11.2018 submitted by the institution.
- 6. **AND WHEREAS**, in its 304th meeting of WRC held on April 2-4, 2019, the Committee observed that letter of approval of faculty of affiliating body along with staff profile approved by competent authority of the university is required to be submitted, thereby given last opportunity to the institution vide WRC letter dated 09.04.2019 to submit reply within 30 days.
- 7. **AND WHEREAS**, vide letters dated 30.04.2019, 10.06.2019, institution requested to issue the order for reduction of intake and vide letter dated 26.04.2019 submitted the copy of teaching staff profile approved by affiliating body.
- 8. AND WHEREAS, vide letters dated 24.07.2020, 02.09.2020 & 29.10.2020, the institution has requested for change of name of the institution from "Madhav Mahavidyalaya" to "Madhav Shiksha Mahavidyalaya" along with demand draft no.354700 & dated 23.07.2020 for Rs.1,50,000/-.

9. AND WHEREAS, the matter was considered by WRC in its 387th meeting held on 09th & 10th June, 2023 and Committee decided as follows:

"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 304th meeting of WRC held on 2-4 April, 2019, the Committee observed as under:

(i) Decision of WRC in 304th meeting was communicated to the institution vide letter dated 09.04.2019.

The institution submitted reply vide letter dated 26.04.2019.

(ii) Vide letters dt. 24.07.2020, 02.09.2020 & 29.10.2020, the institution has requested for change of name of the institution alongwith demand draft No. 354700 & dt. 23.07.2020 for Rs.1,50,000/-

(iii) WRC in its 290th meeting held on 21-23 March, 2018 decided to issue continuation letter for reduced intake as soon as the institution submits the FDR for Rs.5.00 lakh. The institution submitted original FDR of Rs.5.00 lakh along with other FDRs vide letter dated 17.09.2018.

In view of the above, the Committee decided as under:

1. Reduction of intake from 100 (two units) to 50 (one unit) for B.Ed. course be permitted from the date of issue of letter with a copy endorsed to State Govt., affiliating body and others concerned and same shall be uploaded on NCTE web portal.

2. Change of name of institution from "Madhav Mahavidyalaya" to "Madhav Shiksha Mahavidyalaya" be permitted with a copy endorsed to State Govt., affiliating body and others

concerned and same shall be uploaded on NCTE web portal.

3. The processing fee of Rs.1,50,000/- is not required for change of name of institution, hence the

same shall be returned to the institution.

- 4. Letter of clarification be issued to the institution giving 15 days time to make its official website functional by maintaining and uploading all the mandatory disclosure documents including current approved list of faculty in light of Clause 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014 as amended time to time."
- 10. NOW THEREFORE, in terms of above decision taken by WRC, the permission is hereby granted regarding change of name of the institution for B.Ed. course from "Madhav Mahavidyalaya, Vivekanand Marg, Lashkar, Gwalior, Madhya Pradesh" to "Madhav Shiksha Mahavidyalaya, Vivekanand Marg, Lashkar, Gwalior, Madhya Pradesh". Other decisions taken by WRC are being communicated separately.
