WHEREAS, recognition was granted to the institution, namely, HICT SHIKSHA MAHAVIDYALAYA, SURVEY NO.514, PH.H. NO.45, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting **B.ED.** course vide order dated 09.08.2005.

- 1. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 10.02.2015.
- 2. AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 31.05.2015.
- 3. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."
- 4. AND, WHEREAS, in Compliance, Show Cause Notice was issued to the institution on 30.08.2016 and the reply of Show Cause Notice was received on 20.09.2016.
- 5. AND WHEREAS, the matter was placed in 284th Meeting of WRC held on November 28-29, 2017 and the Committee decided that "... In response to the Show Cause Notice dated 30.08.2016, the institution has submitted a staff list of 1+15 faculty members approved by the competent authority but not in original. Further, the subjects at the PG level have not been mentioned.

Secondly, Building Completion Certificate in the format and counter signed by a Govt. Engineer in original should be submitted and photocopy of the FDR of Rs. 4.00 lakhs is submitted but additional FDR of Rs.4.00 lakhs (in joint name) in original should be submitted. (Total requirement is 12.00 lakhs)

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- 6. AND, WHEREAS, letter for clarification was issued to the institution on 01.12.2017 and the reply was received on 01.01.2018.
- 7. AND WHEREAS, the matter was placed in 297th Meeting of WRC held on September 13-14, 2018 and the Committee decided that "... Consequent to the issue of Revised Recognition order, Show Cause Notice dated 30.08.2016 followed by a compliance letter dated 01.12.2017 were issued.

Reply submitted by the institution on 01.01.2018. The institution has still not submitted the staff list approved by the Registrar. It has also not submitted additional FDRs for Rs.4.00 lakhs.

Hence, Recognition is withdrawn from the end of the academic session."

- 8. AND WHEREAS, thewithdrawal Order issued to the institution on 25.09.2018. The institution filed appeal on 16.11.2018 and regulatory file sent to NCTE, Hqr. On 23.01.2019.
- 9. AND WHEREAS, the appeal order dated 11.03.2019 remand back the case to WRC for necessary
- 10. AND WHEREAS, the matter was placed in 306th Meeting of WRC held on April 29-30, 2019 and the Committee decided that "...The Committee considered reply of the institution dated on 17/03/2017 along with order of Hon'ble High Court of Delhi at New Delhi dated 15/04/2019 received in WRC office on 23/04/2019 and observed that: -
- A letter of approval of faculty of affiliating body along with detailed staff profile approved by competent authority of the University is required to be submitted as per NCTE amendment Regulations 09/06/ 2017.

Hence, the committee decided to confer last opportunity to the institution to submit the above within 30 days failing which recognition will be withdrawn under section 17 of NCTE Act, 1993."

- 11. AND WHEREAS, the clarification letter issued to the institution on 01.05.2019. Latter dated 10.05.2019 received in WRO on 13.05.2019 along with order of Hon'ble High Court of Delhi at New Delhi dated 08/05/2019.
- 12. AND WHEREAS, the matter was placed in 307th Meeting of WRC held on May 30-31, 2019 and the Committee decided that "...The Committee considered the Hon'ble High Court of Delhi in W.P.(C) 4959/2019 & CM APPL 22067/2019-S order dated 08/05/2019.

However, the case of the institution was considered by the committee in its 306th meeting held on 29-30 April 2019 and given the last opportunity to submit a letter of approval of faculty of affiliating body along with detailed staff profile approved by competent authority of the University is required to be submitted as per NCTE amendment Regulations 09/06/2017 within 30 days.

The institution has submitted reply dated 29/05/2019 and the committee considered the reply as per NCTE Regulations 2014 and found in order.

Hence, the committee decided to restore the recognition for B.Ed. programme".

- 13. NOW THEREFORE, this formal order is issued restoring the recognition of the institution i.e. HICT SHIKSHA MAHAVIDYALAYA, SURVEY NO.514, PH.H. NO.45, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH for B.Ed. course of two year duration with an intake of 100 students (Two basic unit) subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 14. Further, the institution is required to fullfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 15. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, forinformation of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 17. The institution shall adhere to the mandatory disclosure in the prescribed format and display upto-date information on its official website.
- The institution shall make available the list of students admitted on its official website.
- The institution shall fill the information on GIS Portal on the NCTE Website.
- 20. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
