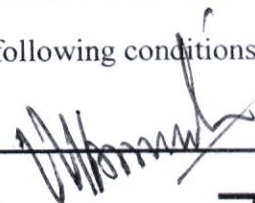

2. **AND WHEREAS**, on scrutiny of the application, the documents attached therewith, the affidavit submitted and the inspection report dated 27 to 28 February, 2022 received from Visiting Team and compliance report of letter of Intent dated 24.05.2022, submitted by the institution the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said Teacher Education Programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the said programme.

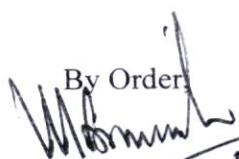
3. **NOR THEREFORE**, in exercise of the powers vested under Section 14/15(3)(a) of the of the NCTE Act, 1993, the Western Regional Committee, NCTE hereby grants recognition/permission to **Ideal College of Master Education, Plot/ Khasra No. 2141/303, Village- Rajgarh, Street No. Hisar Road Rajgarh, Tehsil- Rajgarh, District- Churu-331023, Rajasthan** for conducting **M.Ed. Programme** of two years duration from the academic session **2025-2026** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 with details given below:-

4. The said recognition/permission is subject to fulfillment of the following conditions:



- a. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint operation mode with Regional Director of WRC, NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
 - b. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - c. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - d. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the M.Ed. course should always remain in position.
5. Further the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, Affiliating University / Body, the State Government etc., as applicable.
6. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
7. The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information / documents as per Clause 7(14) of the NCTE Regulations 2014 as amended from time to time.
8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
9. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made or issued thereunder, the action including withdrawal of recognition/permission shall be taken by the Western Regional Committee under the provisions of Section 17(1) of the NCTE Act.
