



RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **GREEN VALLEY COLLEGE, 300/1, VILL BANJARI, SARVADHARM C SECTOR, KOLAR ROAD, BHOPAL-462043, MADHYA PRADESH** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/2-32/223236/74/2005/4902 dated 27.06.2005.

AND WHEREAS, Revised Recognition order was issued to **GREEN VALLEY COLLEGE, 300/1, VILL BANJARI, SARVADHARM C SECTOR, KOLAR ROAD, BHOPAL-462043, MADHYA PRADESH** vide order No. F.No. WRC/APW01399/223236/2015/ 148472-479 dated 31-05-2015 for **B.ED** of Two Years Duration with an annual intake of 100 students for two basic unit of from the academic session 2005-2006.

AND WHEREAS, the matter was placed in **237th** Meeting of WRC held on December 21-22, 2015 and the Committee decided that:

"...The case file was seen. The reply of the institution was examined in the context of the inspection report of the NCTE hqrs conducted under section 13 of the NCTE Act, 1993. The following lacunae are still existing as seen from the reply of the institution:-

1. The institution has still not reported actual action taken for obtaining NAAC Accreditation Certificate;
2. With respect to the salary of the staff, the institution has reported that the staff is on probation period. Once they are permanent, staff rules will be followed;
3. It is not understood from where this concept of probation has come. Once an institution obtains approval of the affiliating body on the names of the staff members, the appointments are/should be as per the rules of the State Government/affiliating body. It is very clear that the institution is not paying proper salary to the staff by cheque and giving CPF etc.; and
4. The institution has not provided proof that the shortage of one staff member has been made good.

Hence, Show Cause Notice be issued on the above grounds."

AND WHEREAS, a Show Cause notice was issued to the institution on 05.01.2016 and its reply received on 04.02.2016.

AND WHEREAS, the matter was placed in **246th** Meeting held on **March 16-18, 2016** of WRC and the Committee decided that:-

"...The case file was seen. Consequent to the consideration of the reply of the institution, to the points raised after inspection under Section 13, the WRC had issued a Show Cause Notice on 05/01/2016. The institution vide reply dt. 04/02/2016 has given the following responses :

- I. The salary statement of the staff for the month of January has been enclosed. However, a certificate from the bank has not been submitted.
- II. The institution should appoint staff as per the NCTE Regulations, 2014 i.e. 16 faculty members for two units of the B.Ed. course.

Hence, Clarification be obtained on the above grounds."

AND WHEREAS, the clarification letter issued to the institution dated 22.03.2016 & the reply received in WRC 01.04.2016.

AND WHEREAS, the matter was placed in **252nd** Meeting held on **May 09-10, 2016** of WRC and the Committee decided that:-

"...The case file was seen. Clarification letter was issued on 22/03/2016. The institution has submitted a certificate from the Bank about Salary payment. The institution has also informed that they have started the process of appointment of sixteen faculty members for two units of the B.Ed. course. They are having a eight faculty members at present.

The institution should submit Compliance in this matter before 30th of May 2016."

AND WHEREAS, the clarification letter issued to the institution dated 17.05.2016 & the reply received in WRC 31.05.2016.

AND WHEREAS, the matter was placed in **254th** Meeting held on **June 07-09, 2016** of WRC and the Committee decided that:-

"...The case file was seen. Clarification letter was issued on 17/05/2016 and reply was received on 31/05/2016. The institution was required to appoint 16 faculty members for two units of the B.Ed. course.

The institution has enclosed a list of 8 faculty members, which is a photocopy and not approved by the affiliating body. The institution has also enclosed the minutes of the selection committee for the appointment of 8 other faculty members. However, the list does not contain any details about the faculty members nor any letter has been received from the University regarding selection process.

*Since, the institution is having only 8 faculty members, it can run the B.Ed. course with only one unit from the session 2016-2017. As per the NCTE notification, faculty members for the additional unit of the B.Ed. course should have been appointed by 29th of February, 2016. Since 29th of February, 2016 was the deadline for the submission of approved staff list and the institution has not submitted the approved staff list of 16 faculty members, **the Committee decided that the intake of the institution is reduced to one unit of 50 students. The institution be informed that from the academic session 2016-2017, recognition is only for one unit of the B.Ed. course."***

AND WHEREAS, vide Order dt. 10.06.2016 NCTE has reduced intake from Two(2) units(100 students) to one (1) unit (50 students) to conduct of B.Ed. course.

AND WHEREAS, the matter was placed in **325th** Meeting of WRC held on January 09, 2020 and the Committee decided that:

"...As per direction of the Hon'ble High Court vide Order dated 18.12.2020 and, the original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

- 1. The institution is required to submit a fresh faculty list duly approved by the affiliating body alongwith faculty approval letter.*



In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for STC programme."

AND WHEREAS, a Final Show Cause notice was issued to the institution on 20.01.2021 and its reply received on 28.01.2021.

AND WHEREAS, the matter was placed in **336th** Meeting of WRC held on March 24-25, 2021 and the Committee decided that:

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that: -

1. The institution has not submitted latest staff list in prescribed format duly approved by the Registrar of concerned affiliating body along with approval letter issued by the concerned affiliating body indicating the date of Notification of Ph.D./NET of each faculty members.

Hence, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act 1993 to submit the notarized / certified documents on the above-mentioned grounds within 30 days from the date of issue of this Final Show Cause Notice."

AND WHEREAS, a Final Show Cause notice was issued to the institution on 07.04.2021 and its reply received on 11.06.2021.

AND WHEREAS, the matter was placed in **337th** Meeting held on **July 07-09, 2021** of WRC and the Committee decided that:-

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:

1. The Show Cause Notice was issued to the institution on 07th April 2021 with a direction to submit reply within 30 days, as per the decision of WRC.
2. The reply to show cause notice submitted by the institution is not acceptable.

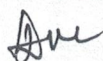
In view of the above, the Committee decided that recognition of the institution be withdrawn from the academic session 2022-2023 u/s 17 of the of the NCTE Act for B.Ed (Urdu) programme.

AND WHEREAS, the Withdrawal order was issued to the institution on 23.07.2021.

AND WHEREAS, the institution filed an Appeal to the Council dt. 31.08.2021 and the Council vide its order dt 22.10.2021 remands back the case to the WRC, NCTE for necessary action and its reply received on 22.11.2021.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 14562/2021 dt. 17.12.2021. The operative parts is produced below:-

"...In these circumstances, the writ petitions allowed with costs. By virtue of the order of the Appellate Committee dt. 22.10.2021, the withdrawal order of the WRC dt 23.07.2021 stands quashed. The WRC is directed to issue an order of restoration of recognition within five days from today, which will govern the rights and contentions of the parties, until and unless a



fresh withdrawal order is passed by the WRC. The status of the petitioner will also be updated on the website of the NCTE."

NOW THEREFORE, recognition of the institution viz to **GREEN VALLEY COLLEGE, 300/1, VILL BANJARI, SARVADHARM C SECTOR, KOLAR ROAD, BHOPAL-462043, MADHYA PRADESH** for **B.Ed. course with an annual intake of 50 students (one unit)** is hereby restored.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. **31.05.2015**.
