RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely **Narmada Education Society College of Education, Near S.N.G. School, Hoshangabad, Madhya Pradesh** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/2k/370-375 dated 15.01.2001. & WRC/5-6/Appeal/213020/2009/60870-60876 dated 26.09.2009.

- 2. AND WHEREAS, the letter for Affidavit Regarding Acceptance and Compliance of NCTE Regulations, 2014 was issued to the institution the reply was received on 27 -01-2015.
- 3. AND WHEREAS, Revised Recognition order was issued to **Narmada Education Society College of Education, Near S.N.G. School, Hoshangabad, Madhya Pradesh** vide order No. WRC/APW07427/213020/2015/148820 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.
- 4. AND WHEREAS, the institution has not submitted Compliance of revised recognition order.
- 5. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 6. AND WHEREAS, a Show Cause notice was issued to the institution on 20.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
 - 1) Staff Profile for the session 2015-2016 duly approved by the affiliating body.
 - 2) Originally notarized Building Completion Certificate.
- 7. AND WHEREAS, the reply of show cause notice was submitted by the institution on 16.08.2016.
- 8. AND WHEREAS, the matter was placed in 301^{th} Meeting held on January 17^{th} – 18^{st} , 2019 of WRC and the Committee decided that." Consequent to the issue of Revised Recognition order, Show Cause Notice dated 20.07.2016 was issued.

The institution in its reply dated 08.08.2016 has submitted a photocopy of staff profile of 10 faculty members and 03 faculty members not approved by affiliating body for B.Ed. course and photocopy of staff list of 1+4 faculty members for M.Ed. course approved by the competent authority.

FDRs have been submitted.

Building Completion Certificate issued by competent authority not submitted.

The institution should submit the latest faculty list duly approved by the competent authority as per the NOTE Regulations, 2014 and NCTE notification published on 09.06.2017 in original.

Hence, Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- 9. AND WHEREAS, the Clarification letter was issued to the institution on 24.01.2019. Accordingly, the institution has submitted reply of Clarification dt. 22.04.2019.
- 10. AND WHEREAS the matter was placed in 310th Meeting held on August 19-21, 2019 of WRC and the Committee decided that "The compliance letter was issued to the institution vide letter dated 24/01/2019 and reply received on 23/02/2018, 12/04/2019 and letter dated 25/05/2019 from Barkatullah University, Bhopal.

On perusal of the reply of the institution the committee observed that:

- The institution has submitted photocopy of 1+9 staff profile in which percentage of faculty at Sr. No. 6 is with less than 55 % marks in P.G. subject.
- In the additional staff list of 8 faculty members all the staff members are not qualified (not having NET/ Ph.D) as per NCTE amended Regulations 9/6/2017.
- FDRs Rs. 7+5 lakhs not submitted.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

- 10. AND WHEREAS, the withdraw Order was issued to the institution on 04.09.2019. Accordingly, the institution has submitted reply of Clarification dated. 22.04.2019, 14.05.2019 & 11.06.2019.
- 11. AND WHEREAS, the institution has filed an appeal NCTE, Hqrs. On 24.10.2019. The appellate Authority vide its order dated 02.03.2020 remanded back the case to the WRC, NCTE, for necessary action and institution filed W.P.(C).5218/2019 dated 13.08.2020 in Hon'ble High Court New Delhi.

AND WHEREAS, a letter was issued to the Higher Education Department, to add name of the institution in recognition list of the NCTE, WRC vide latter dated 25.08.2020.

12. AND WHEREAS, the matter was placed 316th Meeting of WRC held on 27th to 28 August & 04th September 2020.

The WRC examined the documents submitted by the institution in response to the order of the Appellate Authority and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for B.Ed course with an annual intake of 100 students (Two units) be restored from the date of issue of order.

Further, the WRC noted that the FDRs submitted by the institution have been matured. The WRC decided that the FDRs submitted by the institution towards Endowment and Reserve Fund be sent to the institution for renewal.
