Withdrawal Order

WHEREAS Recognition/Permission was granted to the institute INSTITUTE OF MANAGEMENT & TECHNOLOGY, SHA-SHIB COLLEGE OF SCIENCE & MANAGEMENT, NH-12, JAIPUR ROAD, BHOPAL, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED course with an intake of 100 from the academic session 2003-2004.

2. WHEREAS on the direction of the NCTE headquarters, New Delhi to WRC Clarification was issued on 05/11/08 vide letter No.WRC/223085/109/2008/45927. The representation submitted by the institution on 11/11/08.

5. AND WHEREAS the matter was again considered by the Committee in its 112<sup>th</sup> meeting held on December 7-8, 2008 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting B.ED course from the next academic session.

6. Now, therefore recognition of the INSTITUTE OF MANAGEMENT & TECHNOLOGY, SHA-SHIB COLLEGE OF SCIENCE & MANAGEMENT, NH-12, JAIPUR ROAD, BHOPAL, MADHYA PRADESH in terms of section 17(1) of the NCTE Act, 1993 is hereby Withdrawn from next academic session on the following grounds.

1. Approved building plan not submitted.

7. Affiliating Body/ State Govt. are advises not to admit/ allot any student in B.ED in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.
