- 4. AND WHEREAS Council passed an order No F.No.89-432/2009/Appeal dated 18/08/2009 in the appeal filed by the institution and set aside the order of WRC 13/04/2009 with direction to WRC to restore the recognition of the institution immediately.

Refusal order

WHEREAS, the Western Regional Committee of NCTE, vide order No.WRCAPW00649/223191 WRC/5-6/2007 dated 26/07/2007, issued u/s 14 of the National Council for Teacher Education Act 1993, had granted recognition to NAGAJI INSTITUTE OF TEACHERS EDUCATION, A1/8, VINAY NAGAR SECTOR-4, GWALIOR MADHYA PRADESH for conducting B.Ed course with annual intake of 100.

- (2) AND WHEREAS, the Hon'ble High Court of Judicature at Jabalpur, vide common order dated 31-07-2008, passed in WP 6113/2008 and WP 8936/2008, directed the Apex body of the NCTE to find out whether the said recognitions were valid as per the NCTE Act and the Regulations framed there under.
- (3) AND WHEREAS, in compliance of the Hon'ble High Court direction the inspection of the institution was conducted by Apex body of NCTE under section13 NCTE Act 1993.
- (4) AND WHEREAS, in compliance of the Hon'ble High Court directions, the Apex body of the NCTE submitted its report before the Hon'ble High Court that the institution did not fulfil the prescribed norms and standards on which the Hon'ble High Court its vide common order dated 19-02-2009, passed in WP 6146/2008 and 3 other matters, directed the NCTE to communicate the decision of refusal of recognition with liberty to the institution to prefer written representation as per the provisions of the NCTE Act 1993,
- (5) AND WHEREAS, in compliance of the Hon'ble High Court directions and as per instructions of the Apex body of the NCTE, the prima facie decision to withdraw the recognition was communicated vide letter dated 28/02/2009 to the institution on account of following deficiencies to prefer written representation.
- 1- The built up area of 15888 sq.ft is slightly less than the required norms of 1500 sq.mt
- 2- Out of 8 Persons appointed six of them have been appointed after June 2008 and there is only two teachers who have been continuing since February and November 2007.
- 3- The institution failed to establish that they have staff during the accedemic Session 2007-2008.

- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to NAGAJI INSTITUTE OF TEACHERS EDUCATION, A1/8, VINAY NAGAR SECTOR-4, GWALIOR, MADHYA PRADESH for B.Ed. of one year from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
- (a) The institution shall ensure that it gets duly affiliated for this course to the concerned University and all other formalities required by the University are also completed before the commencement of the course and admission of the students to the course and a report to this effect should be sent to the Committee.

(d) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).

(e) The institution shall comply with the various other norms and standards as prescribed in the NCTE Regulations.

4. Recognition is subject to the condition that the affiliating University shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/State Government.

5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

6.
