AND WHEREAS, the revised recognition order was issued to IES COLLEGE OF EDUCATION, KHASRA NO. 514/1, 322, AND 323, PATWARI HALKA NO. 33, VILLAGE-KALKHEDA, VIKASKHAND-FANDA, PATIBAD MAIN ROAD, TEHI-HUZUR, BHOPAL-462044, MADHYA PRADESH vide order No. WRC/APW04031/225032/M.P/2015/135970-977 dt. 20.05.2015 for M.Ed. Programme of two years duration with an annual intake of 50 students (One basic unit of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "..issued Show Cause Notice to the institution of the condition maintained in revise

AND WHEREAS, a Show cause notice was issued to the institution on 06.01.2017 for submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

- 1) Staff Profile for the session 2015-2016 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the institution has submitted reply of show cause notice vide letter dt. 30.01.2017 received in WRO on 31.01.2017.

AND WHEREAS, the matter was placed in 329th Meeting held on February, 17th-19th 2021 and the Committee decided as under:-

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

- 1. The institution is required to submit latest Staff list duly approved by the Registrar of the concerned affiliating body clearly indicating the seal and signature of the Registrar along with faculty approval letter issued by the concerned affiliating body. 2.
- The institution is required to submit FDR of Rs 4.00 lakh more in joint mode as per provision of NCTE Regulation 2014.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for M.Ed programme.

AND WHEREAS, accordingly, a Final Show Cause Notice issued on 11.03.2021 the institution has submitted reply vide date 13.03.2021 received in WRO on 16.03.2021 in response to show cause notice.
