RESTORATION ORDER

WHEREAS an application to the Northern Regional Committee of NCTE on **22.06.2015** for grant of Recognition/permission to institution namely **Shardhalaya Janjati Teacher Training Institute, Near Eidgah, Adarsh Nagar, Rawat Bhatta, Chittorgarh, Rajasthan** for **D.El.Ed.** course with annual intake of 50 students.

2. **AND WHEREAS**, the recognition to the institution was granted vide order F.NRC/NCTE/F-7/RJ-722/9784-93 dt. 26.12.2006 for **D.El.Ed.** course with an annual intake of 50 students from the academic session 2006-2007.

3. **AND WHEREAS**, the matter was placed before WRC in its 316th meeting held on January 27th to 28th August & 04th September 2020 and the Committee decided as under:-

"The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

4. **AND WHEREAS**, Show Cause Notice was issued to the institution on dt. 27.09.2020.

5. **AND WHEREAS**, the matter was placed before WRC in its 321st meeting held on 9th to 11th November 2020 and the Committee decided as under:-

"The original file of the institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 22.12.2006 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Notice was issued to the institution on 27.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.



In view of above, the Committee decided that the recognition of D.El.Ed. programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-22."

5. **AND WHEREAS**, accordingly, Withdrawn was issued to the institution vide order no. WRC/NCTE/RJ-722/STC/321st/2020/212347-212352 dt. 07.12.2020.
6. **AND WHEREAS**, the institution filed an appeal and the appellate authority vide order date 02.06.2021 has directed the following:-

After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded that appellant institution is required to submit separate replies to the S.C.Ns as well as separate proposals for shifting within a period of 15 days of the issue of appeal order.

Now therefore, the Council hereby remands back the case of Shradhalaya Janjati Teacher Training Institution, Shree Ganesh Nagar, Rawatbhata, Chittorgarh, Rajasthan to the WRC, NCTE, for necessary action as indicated above.

7. **AND WHEREAS**, the institution had approached the Hon'ble High Court of Delhi At New Delhi, in W.P. (C) No. 9775/2021 dt. 7.9.2021. The operative part is produced here below:-

"...Having regard to the aforesaid orders, there is no ground for the respondents to have delayed the issuance of the restoration order. It is also declared that the withdrawal order dated 07.12.2020 stands quashed by reason of the order of the Appellate Committee. The writ petition is, therefore, allowed and the respondents are directed to issue a restoration of recognition order within three days from today. The petitioner will be permitted to participate in counselling and admit students for this year, for which the counselling will be held shortly, and for subsequent years, until a fresh order of withdrawal is passed."

8. **NOW THEREFORE**, the institution viz Shardhalaya Janjati Teacher Training Institute, Near Eidgah, Adarsh Nagar, Rawat Bhatta, Chittorgarh, Rajasthan for D.El.Ed. course with an annual intake of 50 students issued vide order dt. 26.12.2006 is hereby restored.
