VT for shifting of premise be constituted."

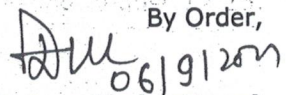
5. **AND WHEREAS**, VT was conducted on 18-19/05/2021 and VT report has been received on 25.05.2021.
