RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **LATE SHRI LAXMANJI MOTGHARE CHARITABLE TRUST, LATE SHRI DNYANESHWARJI MENGHARE SHIKSHAN MAHAVIDYALAYA, AT POST TAH. DESAIGANJ WADSA, GADCHIROLI, MAHARASHTRA** under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. course (100 Intake) vide order No. WRC/5-6/96/2007/20726-20731 dated 30.07.2007.

AND WHEREAS, Revised Recognition order was issued to **LATE SHRI LAXMANJI MOTGHARE CHARITABLE TRUST, LATE SHRI DNYANESHWARJI MENGHARE SHIKSHAN MAHAVIDYALAYA, AT POST TAH. DESAIGANJ WADSA, GADCHIROLI, MAHARASHTRA** vide order No. F.No. WRC/APW02792/123356/2015/ 140200-140213 dated 31.05.2015 for B.Ed. of Two Years Duration from the academic session 2015-2016.

AND WHEREAS, the matter was placed in 312 Meeting held on January 27-29, 2020 of WRC and the Committee decided that

"...On careful perusal of the file of the institution and other related documents, the Committee observed as under :-

- Revised recognition order was issued to the institution on 31.05.2015 with certain conditions. The compliance to the Revised recognition order was not received.
- The Show Cause Notice dated 14.03.2017 was issued to the institution on account of non compliance to the revised recognition order.
- No reply / required documents have been received from the institution.

The Committee resolved to give last opportunity to the institution to submit compliance to the Revised Recognition Order as per NCTE Regulations 2014, as amended vide Notification dated 09th June 2017 within 30 days.

AND WHEREAS, the Final Show Cause Notice was issued to the institution on 10-02-2020 and its reply not received.

AND WHEREAS, the matter was placed in 316th Meeting held on August 27-28 & 03 September, 2020 of WRC and the Committee decided that

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision.

AND WHEREAS, the Show Cause Notice was issued to the institution on 29-09-2020 and its reply not received.

AND WHEREAS, the matter was placed in 321 Meeting held on November 11, 2020 of WRC and the Committee decided that "the original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 30.07.2007 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Noted was issued to the institution on 29.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-21.

AND WHEREAS, the Withdrawal order was issued to the institution on 20.12.2020.

AND WHEREAS, the matter was again placed before WRC in its 339 meeting held on 28-30 July 2021. The Committee decided as follows -

"... This is a RPRO case and same was remanded back by the Appellate Authority. The WRC noted that the institution has requested to give 3-4 years time limit to complete the construction of the permanent building. The WRC decided that as per provisions of NCTE Regulations, the institution was to shift to its own building within 3 years of recognition i.e. on or before 30th July 2010, hence, the request of the institution is not acceptable.

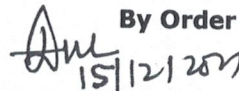
In view of the above, the Committee decided that the decision for withdrawal taken by WRC in its 322nd meeting stands in respect of B.Ed course."

AND WHEREAS, the Withdrawal order was issued to the institution on 28-08-2021.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 11508/2021 dt. 7.10.2021. The operative part is produced here below:-

"... In view of the above, there is no impediment to the petitioner participating in the counselling, and admitting students for the academic session 2021-2022. The NCTE is directed to reflect the status of the petitioner as a recognised institution for the year 2021-22 on its website. The NCTE is also directed to communicate the same to the petitioner's affiliating university, and the concerned State Government within one week from today..."

NOW THEREFORE, recognition of the institution viz **LATE SHRI LAXMANJI MOTGHARE CHARITABLE TRUST, LATE SHRI DNYANESHWARJI MENGHARE SHIKSHAN MAHAVIDYALAYA, AT POST TAH. DESAIGANJ WADSA, GADCHIROLI, MAHARASHTRA** for **B.Ed.** course with an annual intake of 100 students (Two unit) is hereby **restored for the session 2021-2022** with an annual intake mentioned in the revised recognition order issued vide order dt. 31.5.2015.
