#### Withdrawal Order

WHEREAS Recognition/Permission was granted to the institute **Pickthali College Of Education**, **8, Eidgah Hills,Bhopal 462001 Madhya Pradesh** under section 14/15 of NCTE Act, 1993 for conducting **B.ED** course with an intake of **100** from the academic session **2005-2006**.

- 2. WHEREAS on the direction of the NCTE headquarters, New Delhi to WRC to conduct the inspection to the institutions u/s 17 of the NCTE Act 1993 and in compliance with the said direction the Western Regional Committee constituted a Visiting Team u/s 17 of NCTE Act, 1993 to Visit the institution. Accordingly the inspection of the institution was conducted.
- 3. AND WHEREAS, the matter was considered by the WRC in its 108<sup>th</sup> meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-
- 1. The land area of 2400 sq. ft. is less than the prescribed norms.
- 2. Built-up area is also not adequate.
- 3. Multipurpose hall is not available.
- 4. Room size is not adequate.
- 4. AND WHEREAS the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before Withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on **08.10.08**.
  - 5. AND WHEREAS the matter was again considered by the Committee in its 111<sup>th</sup> meeting held on 21.11.08 and having taken into consideration all the relevant facts of the case, it was decided to Withdraw recognition for conducting **B.ED** course for the next academic session.
  - 6. Now, therefore recognition of the institution **Pickthali College OfEducation**, **8**, **Eidgah Hills,Bhopal 462001 Madhya Pradesh** in terms of section 17(1) of the NCTE Act, 1993 is hereby Withdrawn form next academic session on the following grounds.
  - 1. The institution is not having land area & built-up area as per NCTE norms 2007.
  - 2. Multipurpose hall and Room size are not adequate as per NCTE norms 2007.

Refusal order

WHEREAS, the Western Regional Committee of NCTE, vide order No.WRC/2-32/223319/77(CON)/2005/7683 dated 26.09.2005, issued u/s 14 of the National Council for Teacher Education Act 1993, had granted recognition to PICKTHALI COLLEGE OF EDUCATION, 8, EIDGAH HILLS, BHOPAL 462001 MADHYA PRADESH for conducting B.Ed course with

annual intake of 100.

(2) AND WHEREAS, the Hon'ble High Court of Judicature at Jabalpur, vide common order dated 31-07-2008, passed in WP 6113/2008 and WP 8936/2008, directed the Apex body of the NCTE to find out whether the said recognitions were valid as per the NCTE Act and the Regulations framed there under.

- (3) AND WHEREAS, in compliance of the Hon'ble High Court direction the inspection of the institution was conducted by Apex body of NCTE under section13 NCTE Act 1993.
- (4) AND WHEREAS, in compliance of the Hon'ble High Court directions, the Apex body of the NCTE submitted its report before the Hon'ble High Court that the institution did not fulfil the prescribed norms and standards on which the Hon'ble High Court its vide common order dated 19-02-2009, passed in WP 6146/2008 and 3 other matters, directed the NCTE to communicate the decision of refusal of recognition with liberty to the institution to prefer written representation as per the provisions of the NCTE Act 1993,
- (5) AND WHEREAS, in compliance of the Hon'ble High Court directions and as per instructions of the Apex body of the NCTE, the prima facie decision to withdraw the recognition was communicated vide letter dated 28/02/2009 to the institution on account of following deficiencies to prefer written representation.
- (i) \ Land area 2400 sq. ft. as against the requirement of 2500 sq.mt as per the NCTE Regulation 2007.
- (ii) | Built up area is not mentioned
- (iii) Multipurpose hall size is not as per NCTE Norms
- (iv) \ Library is inadequate, instructional facilities is not available
- (v) \Building plan is not approved by the competent authority.

- (6) AND WHEREAS, WRC considered the reply along with original file and all relevant document, considered writ petition numbers 12133 of 2007, 6146 of 2008, 11095 of 2008, 11725 of 2008 and 11360 of 2008 with the legal opinion in its 115<sup>th</sup> meeting held on 21-23 March 2009 and found that the said institution a falls under the principle of Jan Seva Shiksha Samiti and decided that the recognition of the said institution to be **refused** under section 14(3) (b) of NCTE Act.
- (7). NOW, THEREFORE grant of recognition/permission to **PICKTHALI COLLEGE OF EDUCATION**, **8, EIDGAH HILLS**, **BHOPAL 462001 MADHYA PRADES** or conducting the B.Ed course under section 14(3) (b) of the NCTE Act, 1993, is hereby **refused** on following grounds-
  - 1. Reply not received within stipulated time.
- (8). Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, NewDelhi -110002 against this order under Section 18 of the NCTE Act 1993 within 60 days of the issue of this order, The guidelines of appeal are enclosed herewith.
