RECOGNITION ORDER

Whereas in terms of Section 15(1) of the NCTE Act, 1993, Shri Sachhidanand Shikshan Sanstha's College of Physical Education, khasra No. 25, 26, 29 & 27/2, Village – Koradi, Mahadula, Post office – Koradi, Tehsil – Kamptee, Dsixtt. – Nagpur, Maharashtra. had submitted on 17/4/2008 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the M.P.Ed. course with an annual intake of 30.

- And whereas, the matter was placed before WRC in its 121" meeting and the Committee dedded that
 application be rejected and file closed on the following points.
 - Reply not received within stipulated time.
- 3. And whereas, order was issued to the institution on 14/7/2009. The institution preferred appeal to NCTE Hqrs under section 18 of NCTE Act, 1993. The appellate authority passed order dated 6/11/2009; the Council remanded back the case to the WRC for a comprehensive inspection of the institution offering various teacher education courses immediately and thereafter to issue order. The matter was placed before WRC in its 129th meeting and the Committee decided that VT be constituted for the proposed M.P.Ed. course and existing M.Ed., B Ed. and D.Ed.
- 4. And whereas, the inspection of the institution was conducted on 26/2/2011. The matter was placed in WRC in its 134th meeting and the Committee decided that show cause notice be issued to the institution on the following points:
 - Building plan not approved by the Comptent Authority.
 - Total land area required for B.Ed. and M.P.Ed. course is not at per the MCYS storms.
- 5. And whereas, show cause notice was issued to the institution on 12/5/2010. The institution submitted reply dated 29/5/2010 which was placed before WRC in its 142rd meeting and the Committee decided that show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution on the following points:
 - Built up area of 3867.83 sq.mts is inadequate to conduct B.P.Ed., B.Ed., M.Ed., 3 divisions of D.Ed. Including the proposed M.P.Ed. course.
- 6. And whereas, show cause notice was issued to the institution on 13/1/2011. The institution submitted reply dated 5/2/2011 which was placed in WRC in its 147th meeting and the Committee decided to seek clarification from the institution on the following points:
 - Building plan not approved by the competent authority (Panchyat Sachly).
- 2. And whyear, clarification letterwas issued to the institution on 10/4/2011. The institution submitted reply dated 15/4/2011 which was placed before WRC in its 149th meeting and the Committee decided to issue the letter of Intent prior to recognition under clause 7(9) of NCTE Regulations, 2009. Accordingly letter of Intent was issued to the institution on 20/5/2011.
- 8. And whereas, the institution submitted reply dated 21/6/2011 which was placed before WRC in its 153** meeting and the Committee decided to grant recognition under section 15(3)(a) of NCTE Act, 1993 and clause 7(11) of NCTE Regulations, 2009 for M.P.Ed. course with an annual intake of 40 seats from the academic session 2011-2012.

And whereas, as per observation made by NCTE Headquarters vide letter F. No. 40-1/2011/CDN/NCTE
August 26, 2011 the matter was again considered by WRC in its 154th meeting and the Committee observed that:

Shri Datarkar, Associate Professor possesses Ph.D vide provisional certificate No. 511 dated 9/3/2011 as per notification No. Prof. Exam/Ph.D Cell/904 dated 2/11/2010. So the decision taken by WRC stands as it is.

- 10. Now therefore, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to Shri Sachhidanand Shikshan Sanstha's College of Physical Education, khasra No. 25, 26, 29 & 27/2, Village Koradi, Mahadula, Post office Koradi, Tehsil Kamptee, Dsistt. Nagpur, Maharashtra for starting M.P.Ed. Course of PH-PG level of 2 Years with an annual intake of 40 from the academic session 2011-2012
- 11. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.
- 12. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
- 13. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session 2011-2012 failing chich the recognition will be effective from the academic session 2012-2013.
- 14. The recognition /permission will operate for 2011-2012 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University /Affillating Body.
- 15. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 16 The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
- If, at any time, either on sue-moto inspection or on any representation received from any person, the WRC. NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.
