- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to MADAN MAHARAJ COLLEGE, RUN BY MADAN MAHARAJ SMRITI SANSTHAN, KHASRA KH-41, VILLAGE: BHANPUR, BHOPAL, MADHYA PRADESH for conducting D.ED.(CO-ED) course of ELE of 2 year duration with an annual intake of 50(ELE) under clause 7(11) of NCTE( Recognition Norms & Procedure ) Regulation 2007.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
- 5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- 7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 8. Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC , affiliating University/Body , the State Government etc, applicable.

- 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:
  - Copy of the Application Form
  - Land and Building Particulars. (ii)
  - Staff Profile. (iii)
    - Recognition letter. (iv)
    - Information for having fulfilled the norms & standard and other required conditions. (v)
- 11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 12. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. #### ORDER

WHEREAS, the recognition was granted to the institution namely MADAN MAHARAJ COLLEGE, OPP. SUBHASH NAGAR, RAILWAY CROSS, HOSHANGABAD ROAD, BHOPAL, MADHYA PRADESH for D.ED. Course vide order dated 30.10.2006.

AND WHEREAS, WRC in its 152<sup>nd</sup> meeting held from July 10-12, 2011, decided that comprehensive inspection be caused for shifting of B.Ed. and M.Ed. course at the new premises, where, D.Ed. course is already being conducted.

AND WHEREAS, the visiting team constituted by the WRC inspected its new premises on 14.10.2011, but the institution refused for inspection.

AND WHEREAS, the matter was placed in its 159th meeting held from February 7-9, 2012 and the Committee decided that clarification be sought from the institution. Accordingly, letter was issued to the institution on 21.03.2012.

AND WHEREAS, the reply submitted by the institution on 19.04.2012. The matter was placed before WRC in its 163rd meeting held from May 22-24, 2012 and the Committee observed that in this case VT has been constituted for shifting of B.Ed. M.Ed. and D.Ed. course and the VT recommended the shifting of D.Ed. course. However, the management has informed that they have never asked for shifting of D.Ed. course. In this connection, during the discussion an issue has come up that recognition for D.Ed. was given on the basis of the fact that management was already running B.Ed. course and common facilities are required for both. Now, the B.Ed. course has been shifted and the management does not want to shift the D.Ed. course it is necessary the management be asked to submit a complete list of the facilities available with them at their institution Opposite Subhash Nagar Railway Crossing, Hoshangabad, Bhopal. Accordingly, clarification sought from the institution vide letter dated 21.06.2012.

AND WHEREAS, the reply submitted by the institution on 23.07.2012. The matter was placed before WRC in its 169th meeting held from August 22-24, 2012 and the Committee observed that there are two letters from the Society running the institutions known as Madan Maharaj College. In the letter dt. 19.7.2012 it has been written that the Society wants to shift the D.Ed. course to its own premises at KH-41/2, Behind Galla Mandi, Bhanpur, Bhopal. In APW06732/222380 the institution vide its letter dt. 17.7.2012 has written that D.Ed. course is aiready been conducted at KII-41/2, Behind Galla Mandi, Bhanpur. The two letters have been written in a period of three days, and state different position of the Society which are contradictory to each other. Hence, Clarification be issued to APW03659/222187 and APW03659/222187 on this point. Accordingly, letter was issued to the institution on 25.09.2012.

AND WHEREAS, the reply submitted by the institution on 31.10.2012. The matter was placed before WRC in its 178<sup>th</sup> meeting held from January 22-24, 2013 and the Committee decided that the institution has deposited the inspection fee of Rs.50,000/-. Hence, VT be constituted. Accordingly, inspection of the institution was conducted on 07.04.2013.
