WITHDRAWAL ORDER

WHEREAS, the recognition/permission was granted by the Western Regional Committee of National Council for Teacher Education ("NCTE") under Section 14/15 of NCTE Act, 1993 to (MMD COLLEGE, PLOT NO. 2107, 1483, JAGANNATH PURA P.O. MURLI KA PURA, TEHSIL- BHIND, DIST. BHIND-477001, MADHYA PRADESH) for the following Teacher Education Programme:-

2. **AND WHEREAS**, Section 12(k) of the NCTE Act, 1993, empowers the NCTE to evolve suitable Performance Appraisal system, norms and mechanisms for enforcing accountability on recognised institutions. 9. If the institution is not satisfied with this order, it may prefer an appeal under section 18 of the NCTE Act, 1993 through online mode available on NCTE website <https://ncte.gov.in/Appeal/Form/login.aspx> within 60 days from the date of issue of this order.
