#### RECOGNITION ORDER

Course of 2 (Two) Year duration from the academic session 2014-2015.

Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.

The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognic on Norms and Procedure) Regulations, 2009.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
