**ORDER (Shifting of Premises)**

**WHEREAS** recognition was granted to the institution namely, Baba Narayan Das Teacher's Training College," Jaipur Road, Virat Nagar, Distt. Jaipur-303102, Rajasthan vide order No. NRC/NCTE/RJ-914/2008/63519-63524 dated 26.09.2008 for **B.Ed.** course of one year duration with an annual intake of 100 students from the academic session 2008-2009.

2. **AND WHEREAS**, after promulgation of NCTE Regulation 2014, the institution by consented to come under new Regulation by affidavit and the Revised Recognition order (RPRO) was issued to the institution 09.06.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, the institution has submitted an application dated 03.10.2022 requesting for change of name of institution from, "Baba Narayan Das Teacher's Training College," to "**Maharaja Surajmal Teacher Training College.**"

4. **AND WHEREAS**, WRC in its 396<sup>th</sup> meeting held on 06<sup>th</sup> October, 2023 considered the matter and decided as Order dated 10.10.2023 was issued changing the name of the institution from Baba Narayan Das Teachers Training College to **Maharaja Surajmal Teacher Training College.**

5. **AND WHEREAS**, the institution has submitted an application dated 03.10.2022 received on 27.10.2023 requesting for Shifting of premises of the institution, from "**Old Address: Jaipur Road, Virat Nagar, Distt. Jaipur-303102, Rajasthan** to "**New Address: Village-Ajabpura, (NH-148 Manoharpur-Dausa Highway), Post-Bobari, Via-Gathwari, Distt- Jaipur, Rajasthan-303120.**"

6. **AND WHEREAS**, WRC in its 400<sup>th</sup> Meeting held on 13<sup>th</sup> February, 2024 and considered the matter wherein Committee decided that Virtual Inspection Team be constituted for shifting of premises. The Virtual Inspection team has conducted online schedule dated 22.03.2024 and report submitted on 27.03.2024.

7. **AND WHEREAS**, the matter was considered in 404<sup>th</sup> Meeting of WRC held on 21<sup>st</sup> and 22<sup>nd</sup> May, 2024, wherein Committee decided as under:-

*"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:*

1. *On consideration of visiting team report dated 27.03.2024 for shifting of premises along remarks of visiting team members recorded therein, the Committee observed that institution is still deficient on the following grounds:*

- i. *Principal (Dr. Satish Chand Mangal) is not accepted by VT member.*
- ii. *Updated approved faculty list as per NCTE norms and regulations by the affiliating body needs to be submitted.*
- iii. *Library sitting capacity needs to be increased.*
- iv. *Multipurpose Hall is required to be furnished in all respect.*
- v. *Number of classrooms as per NCTE norms and regulations need to be increased.*
- vi. *Action required for having Internet facility in the institution.*
- vii. *Ramp needs to be constructed in all the floors for Divang students.*
- viii. *The address mentioned as mentioned in shifting application is Khasra No.10, Village-Ajabpura, (NH-18 Manoharpur Dausa Highway), Via- Gathwari, The-Jamwaramgrah, Dist. Jaipur, Rajasthan with pincode-303120, whereas the postal department information shows Pin Code of Jamwaramgarh S.O. is 303109, which needs to be clarified by the institution.*

*In view of the above, the Committee decides that show cause notice be issued to the institution giving 21 days to submit reply for further consideration of WRC."*

Accordingly, Show Cause Notice in the matter of Shifting of Premises was issued to the institution dated 03.07.2024.

8. **AND WHEREAS**, the institution has submitted reply dated 21.06.2024 on the basis of minutes uploaded on the web portal of WRC, NCTE.

9. **AND WHEREAS**, the matter was considered in its 408<sup>th</sup> (Part-I) Meeting of WRC held on 12<sup>th</sup> -14<sup>th</sup> November, 2024 wherein Committee decided as under:-

"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:

*Final letter/Notice be issued to the institution to remove the following deficiencies within 15 Days from the date of issue of the letter.*

- i. *Copy of Resignation Letter of Dr. Satish Chand Mangal, Ex-Principal.*
- ii. *Copy of joining letter newly appointed Principal namely Dr. Jitendra Singh.*
- iii. *Copy of Approved latest faculty list by the concerned University as per Clause-5 of Appendix -4 of the NCTE Regulations, 2014 (Amended from time to time) as well NCTE's Gazette Notification dated 09.06.2017.*
- iv. *Details of Chair and Tables available in the library of the institution to maintain sitting capacity as per provision of NCTE Regulations, 2014.*
- v. *Total 12 Number of Classrooms are required as per NCTE Regulations.*
- vi. *Copy of the document pertaining to installation of the internet facility in the institution.*

Accordingly, Final Show Cause Notice for Shifting of Premises was issued to the institution on 20.12.2024. The institution has submitted an e-mail/letter dated 07.12.2024 received in WRC office on 04.01.2025 in response to Final Show Cause Notice.

10. **AND WHEREAS**, the matter was considered by Western Regional Committee in its 417<sup>th</sup> Meeting held on 07<sup>th</sup> -10<sup>th</sup> April, 2025 wherein Committee decided as under:-

*"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with reply of final SCN in the matter of shifting.*

*The Committee decided that shifting of premises of institution is permitted from old address at Viratnagar, Dist-Jaipur, Rajasthan-303102 to new address: Village-Ajabpura, (NH-148 Manoharpur-Dausa Highway), Post-Bobari, Via-Gathwari, Distt-Jaipur, Rajasthan-303120."*

11. **NOW THEREFORE**, the institution is hereby allowed to shift its premises from "Maharaja Surajmal Teacher Training College Jaipur Road, Virat Nagar, Distt. Jaipur-303102, Rajasthan to **"Maharaja Surajmal Teacher Training College, Village-Ajabpura, (NH-148 Manoharpur-Dausa Highway), Post-Bobari, Via-Gathwari, Distt- Jaipur, Rajasthan-303120"** under Clause 8(9) of the NCTE Regulation, 2014.
