WITHDRAWAL ORDER

WHEREAS, the institution, namely; S.S. COLLEGE OF EDUCATION, 3K 47, VINAYAK MARG, SECTOR No.5, HIRAN MAGRI, UDAIPUR PIN - 313001, RAJASTHAN was granted recognition by NRC, NCTE for B.Ed. Course vide Order F.NRC/NCTE/RJ-1043/2007/24610-16 dated-06.08. 2007.with an intake 100 students.

2. ANDWHEREAS, Withdrawal Order No. F.NRC/NCTE/RJ-1043/163rd meeting/2010/ 27296-27302 was issued to the institution on 08.09.2010.

3. ANDWHEREAS, Restoration Order No. F.NRC/NCTE/RJ 1043/237th meeting/2015/ 15452 was issued to the institution on 09.06.2015.

4 AND WHEREAS, Revised Recognition Order No. F.No.NRC/NCTE/RJ-Common Orders/2015/116329-398 dated. 11.06.2015 with an intake of 100 students was issued to the institution.

5. AND WHEREAS, change of status from Women to Co-Education was permitted vide order dated 08.08.2017by NRC in its 264th Meeting (part-5 held from 20th to 23rd february 2017).

6. AND WHEREAS, the matter was placed before WRC in its 316th meeting held on 27th to 28th August & 04th September 2020 and the Committee decided as under: -

"The WRC considered the entire issue in detail and noted that the State of Rajasthan has come under the purview of WRC of WRC vide Gazette notification dated 28th January 2020.

The Revised recognition orders were issued to the institution for B.Ed., B.P.Ed., and M.Ed. course (s) by NRC after promulgations of NCTE Regulations 2014 but not submitted compliance as on date to the conditions mentioned/ stipulated in the Revised Recognition Order issued by NRC-NCTE.

The WRC decided that Show Cause Notice u/s 17 of the NCTE Act 1993 be issued to all such institutions of Rajasthan which were issued Revised Recognition Orders with a direction to submit compliance to the conditions mentioned/ stipulated in the Revised Recognitions Order issued by NRC-NCTE."

7. **AND WHEREAS**, Show Cause Notice was issued to the institution on dt 28.10.2020.

8. **AND WHEREAS**, the matter was placed before WRC in its 371st meeting held on 21st & 22nd September 2022 and the Committee decided as under:-

"...The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Recognition was initially granted to B.Ed. course of one year vide order dated 06.08.2007.
- Recognition to B.Ed. course was withdrawn vide order dated 08.09.2010.
- Restoration order issued dated 09.06.2015.
- Revised order was issued for B.Ed. course of two years dated 11.06.2015.
- In the matter of compliance of revised recognition in light of NCTE Regulations, 2014, 1st Show cause notice issued dated 28.10.2020.
- Latest approved faculty list by the Affiliating Body in NCTE prescribed proforma is not submitted.
- Letter of approval from the University/Affiliating Body not submitted.
- Six months salary statement issued by bank with original signature and seal of issuing authority towards proof of payment made to all the teaching and non-teaching staff.
- The institution has also not submitted Performance Appraisal Report (PAR) for the academic session 2020-2021.

In view of the above, the Committee decided that final Show Cause Notice be issued to the institution u/s 17 of the NCTE Act for B.Ed. programme to submit reply to SCN accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."

9. **AND WHEREAS**, a Final Show cause Notice was issued to the institution on 25.11.2022 and its reply received on 20.12.2022.

10. **AND WHEREAS**, the matter was considered by WRC in its 387th meeting held from 09th & 10th June, 2023 and the WRC decided the matter as under:

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 371st meeting of WRC held on 21st & 22nd September, 2022 the Committee observed as under:

- i. As per decision in 371st meeting, final show cause notice was issued to the institution on 25.11.2022.
- ii. The institution submitted reply vide letter dated 25.11.2022 received in WRC 20.12.2022.
- iii. The Committee considered the reply of the institution and found that the institution is still deficient on the following grounds:

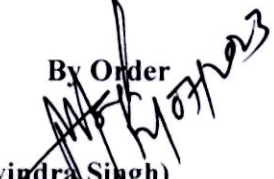
- Bank Statement only in respect of Principal (Dr. Sangeeta Goswami) submitted, others not submitted.
- University approval letter for selection/appointment of faculty is not submitted.
- Non-Academic staff position/ list is not provided by the institution.
- Academic Staff from Sr.No. 2-13 of list of faculty provided is not having NET/Ph.D. qualification in pursuance of NCTE Gazette Notification dated 09.06.2017.

In view of the above, the Committee decided to withdraw recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order with a copy endorsed to State Govt.,

Affiliating Body and others concerned. A copy of the withdrawal order will be uploaded on the NCTE web portal.

11. NOW THEREFORE, In terms of above decision of WRC, the recognition granted to the institution, namely, **S.S. COLLEGE OF EDUCATION, 3K 47, VINAYAK MARG, SECTOR NO-5, HIRAN MAGRI, UDAIPUR PIN – 313001, RAJASTHAN** for B.Ed. course (Code No. RJ-1043) for an annual intake of 100 students (two basic units of 50 students each) is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.

Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website www.ncte.gov.in within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
