WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely GOVT. INSTITUTE OF ADVANCE STUDIES IN EDUCATION, GANGA NAGAR ROAD, DISTT.- AJMER- 334001, RAJASTHAN Vide Order No. F. No. F-3/RJ-10/3834 dated 28.10.1996 for B.Ed. course of 1 year duration with an annual intake of 150 students.

AND WHEREAS, Revised Recognition order was issued to GOVT. INSTITUTE OF ADVANCE STUDIES IN EDUCATION, GANGA NAGAR ROAD, DISTT.- AJMER- 334001, RAJASTHAN vide order No. F.No. NRC/NCTE/RJ-10/2015/120247-252 dated 06-08-2015 for B.ED of Two Years Duration with an annual intake of 100 students for two basic unit of from the academic session 2015-2016.

AND WHEREAS, the matter was placed in 325th Meeting held on January 09. 2021 of WRC and the Committee decided that:-

"...The WRC considered the PIL and also the complaint received against the institution (s) and decided that the institution may be directed to submit the faculty list duly approved by the affiliating body, for all the courses being run in the institution (s).

The WRC also decided that the copy of Show Cause Notice also be marked to the Higher Education Department, Govt of Rajasthan."

a Show Cause Notice was issued to the institution on Accordingly, 21.01.2021 and its reply not received.

AND WHEREAS, the matter was placed in 329th Meeting held on February 17-19, 2021 of WRC and the Committee decided as under:-

- "... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:
 - 1. Recognition was granted to the institution on 28.10.1996 with an annual intake of 150 for B.Ed programme.
 - 2. On promulgation of NCTE Regulation 2014, all the recognized institution conducting B.Ed one year course was required to submit an affidavit for

their willingness to adhere to the provisions NCTE Regulations 2014 and accordingly revised recognition orders for two years B.Ed course was to be issued to the institution.

3. As per records available, the institution mentioned here under conducting B.Ed course has not submitted an affidavit showing their willingness to come under the NCTE Regulations 2014 and the Revised Recognition order for B.Ed course of two years duration has not been issued to the institution.

In view of the above, the Committee decided that Show Cause Notice be issued to the institution to reply within 30 days u/s 17 of the NCTE Act for B.Ed programme.

A copy of the same Show Cause Notice be endorsed to the Commissioner, Department Higher Education, Rajasthan, Jaipur for necessary action in the matter."

Accordingly, a Show Cause Notice was issued to the institution on 07.03.2021 and its reply not received.

AND WHEREAS, the institution had approach to the Judicature for Rajasthan at jodhpur in W.P. (C) 12117/2019 dt. 01.12.2021.

AND WHEREAS, the matter was placed in 370th Meeting held on September 10th and 12, 2022 of WRC and the Committee decided that:-

"...The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Initially, recognition was granted for B.Ed. course of one year duration with intake of 150 vide order dated 28.10.1996.
- Revised order dated 06.08.2015 was issued for B.Ed. course of two years duration with intake of 150 in light of NCTE Regulations, 2014.
- WRC in its 325th meeting held on 9th January, 2021 considered the D.B. Civil Petition PIL No.12447/2019 filed in the Hon'ble High Court of Judicature Rajasthan at Jodhpur i.e. complaint against the institution and the Committee decided that the institution may be directed to submit the faculty list duly approved by the affiliating body, for all the courses being run in the institution(s). The WRC also decided that the copy of Show Cause Notice also be marked to the Higher Education Department, Govt. of Rajasthan. Accordingly, Show Cause Notice u/s 17 was issued dated 22.01.2021 with a copy endorsed to State Govt. and Affiliating Body.
- Matter was considered by WRC in its 329th meeting held on 17th to 19th February, 2021 and accordingly, Show Cause Notice u/s 17 was issued dated 07.03.2021 with direction to submit an affidavit showing their willingness to come under the NCTE Regulations, 2014
- Subsequently, an order dated 01.12.2021 passed by Hon'ble High Court of Judicature for Rajasthan at Jodhpur in D.B. Civil Writ Petition No. 12117/2019 with direction to NCTE to take a final

decision on the show cause notice dated 07.03.2021 and 05.04.2021, preferably within six months for the date of issue of order.

The Committee considered the whole facts enumerated above and observed that the institution is still deficient on the following:

- The institution has not submitted affidavit in response to Show Cause Notice u/s 17 issued dated 07.03.2021.
- The institution has not submitted faculty list for B.Ed. course in NCTE prescribed format duly approved by the Registrar of concerned affiliating body.

In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby **Withdrawn** recognition of **GOVT. INSTITUTE OF ADVANCE STUDIES IN EDUCATION, GANGA NAGAR ROAD, DISTT.- AJMER- 334001, RAJASTHAN** granted for **B.Ed.** course on the grounds mentioned above with effect from the end of the academic session next following the date of communication of the said order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
