RESTORATION ORDER (224591 - The Manager)

WHEREAS, the institution, namely, YUVA VYAVSAIK SHIKSHAN MAHAVIDYALAYA, GUNA ROAD, BARKEDHI, ASHOK NAGAR-MADHYA PRADESH 473331 was granted recognition by WRC NCTE for B.Ed Course with an annual intake of 100 students vide order No. WRC/5-6/92/2006 dated 26.12.2006.

- AND WHEREAS, Revised Order was issued on 31.05.2015 for intake of 100 students 2. vide order no. WRC/APW03639/223482/2015.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th 3. meeting held on 22-24 June, 2016 and the committee decided that show cause notice be issued to the institution.
- AND WHEREAS, as per the above decision of the committee Show cause notice 4. dated 19.09.2016 was issued to the institution.
- AND WHEREAS, the matter was again considered in 268th meeting of WRC held on February 09th -11st, 2017 and as per the decision of the committee Show cause notice 5. dated 15.02.2017 was issued to the institution.
- AND WHEREAS, Institution submitted its reply Vide letter dated 14.03.2017 6. received in WRO on 21.03.2017.
- AND WHEREAS, the matter was again considered in 310th meeting held on August 19th -21st, 2019 and as per the decision of the committee withdrawal order dated 7. 04.09.2019 was issued to the institution.
- AND WHEREAS, Institution filed an appeal before the appellate committee of NCTE u/s 18 of the NCTE Act, 1993 and the committee passed an order dated 8. 02.03.2020 with the following directions,

"AND WHEREAS after perusal of the memorandum of appeal, affidavit, documents on records and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to WRC for revisiting the matter after verifying the authenticity of the documents submitted and issue appropriate order afresh.

NOW THEREFORE, the Council hereby remands back the case of Yuva Vyavsaik Sikshan Mahavidyalaya, Ratikheda (Ashok Nagar) Gram Maroop, Guna Road, Guna, Madhya Pradeshto the WRC, NCTE, for necessary action as indicated above."

- AND WHEREAS, Institution filed Writ Petition no. 5397/2020 before Hon'ble high Court of Delhi which was decided vide order dated 19.08.2020 with the following directions,
 - "...8. In view of the above, in my opinion, the net effect of the order Appellate Authority dated 02.03.2020 is that the order passed by WRC dated 04.09.2009 stands quashed. It is ordered accordingly. The WRC is free to take its decision as per law based on the documents submitted by the petitioner.
 - 9. Accordingly, the writ petition is disposed of. All pending applications, if any, also stand disposed of, All consequential reliefs will be granted to the petitioner including participation in the on-going counselling for academic session 2020-21."
- AND WHEREAS, in compliance of the court Direction of Hon'ble High Court of New Delhi the Institution name was added in the list of recognized institution and letter was sent to commissioner of Higher Education Department Govt of M.P. On 25.08.2020.
- 11. **AND WHEREAS,** Institution filed Writ Petition no. 7611/2021 before Hon'ble high Court of Delhi which was decided vide order dated 03.08.2021 with the following directions,
 - "The petition is, therefore, allowed and the NCTE is directed to issue an order of restoration of recognition. The petitioner will be permitted to participate in counselling and admit students for the year 2021-22 and for subsequent years, until and unless a fresh withdrawal/closure order is passed against it. The status of the petitioner as a recognised institution will also be reflected on the respondent NCTE's website, and

will be communicated by the NCTE to the petitioner's affiliating university as well as to the concerned departments of the State Government. The NCTE is directed to comply with these directions within one week."

- 12. **AND WHEREAS,** in compliance of the above court order WRC issued letter dated 12/08/2021 for permission to participate in the counselling for the year 2021-2022.
- AND WHEREAS, Institution filed contempt petition no. 1817/2023 before the Hon'ble Delhi High Court.
- 14. **AND WHEREAS**, the matter was considered in 398th meeting of WRC held on 15.12.2023 and the committee decided as follows,

"In compliance of order dated 03/08/2021 passed in W.P. No. 7611/2021 and order dated 7/12/2023 passed in the contempt petition No.1817/2023 by the Hon'ble High Court of Delhi filed by YUVA VYAVSAIK SHIKSHAN SANSTHAN, the case was considered by the WRC and decided that the recognition of B.Ed. course granted to the said institution be restored and the status of the institution be updated on the official website of NCTE.

The WRC further decided that a show cause notice w/s 17 of the NCTE Act, 1993 be issued to the institution for submitting compliance report with regard to all the regulations, norms and standards prescribed under the NCTE Regulations, 2014, as amended from time to time, along with the supporting affidavit and documents.

NOW THEREFORE, in compliance of order dated 03.08.2021 of the Hon'ble Court of Delhi in W.P. (C) No. 7611/2021 and decision taken by the WRC in its 398th meeting recognition of the institution viz namely, YUVA VYAVSAIK SHIKSHAN MAHAVIDYALAYA, GUNA ROAD, BARKEDHI, ASHOK NAGAR-MADHYA PRADESH 473331 for conducting B.Ed Course with an annual intake of 100 students is hereby restored.
