RESTORATION ORDER

WHEREAS, the recognition was granted to the institution, namely, MARATHA SHIKSHAN SANSTHA, PLOT NO-281 KAKADDHARA, VILL-TALEGAON, WARDHA, MAHARASTHRA was granted recognition by WRC NCTE for B.ED.(MARATHI) course of one year duration with an annual intake of 100 students vide order no. F.WRC/5-6/88/2006/C-12240 dated 07.03.2007.

- 2. AND WHEREAS after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order F.No.WRC/APW02772/123346/2015/148398-8405 dated 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the institution had requested for reduction of B.Ed. intake from 2 Units (100) to 1 Unit (50) Seats followed by another letter dated 27.06.2018, received in WRC on 28.06.2018 and for re-issuance of the revised order for this purpose.
- 4. AND WHEREAS, the matter was placed in the 294th meeting of WRC held on 4th 5th July, 2018 and the Committee has decided the following:

"The case file was seen. The Management vide letter dated 27.06.2018 has requested to reduce 01 unit of the B.Ed. course.

Hence, reduction of one unit is permitted and the institution is required to submit latest staff list."

- 5. **AND WHEREAS**, the matter was considered by WRC in its 326th meeting held on 22nd to 23rd January, 2021 and as per the decision of the Committee Final Show Cause Notice dated 11.02.2021 was issued.
- 6. AND WHEREAS, the matter was considered by WRC in its 366th meeting held on July 12th & 14th 2022 and the Committee decided that the recognition of B.Ed. programme of institution be withdrawn under clause 17(1) of the NCTE Act, 1993, with effect from the end of the academic session next following the date of communication of the said order. Accordingly, Withdrawn Order was issued dated 14.11.2022.
- 7. AND WHEREAS, institution filed an appeal under Section 18(1) NCTE Act, 1993 before the Appellate Authority at NCTE, New Delhi against the aforesaid withdrawal order.

- AND WHEREAS, in light of order dated 08/04/2021 passed in the W.P. (c) No. 4382/2021 and dated 30.07.2021 passed in W.P. (c) No. 7260/2021 by the Hon'ble High Court of Delhi the withdrawal Order dated 14.11.2022 passed by WRC was set-aside by the Appellate Authority vide its order dated 07/03/2023 and remand back to WRC.
- AND WHEREAS, WRC in its 385th meeting held on 17th may, 2023 has taken the following decision, "the committee unanimously resolved that all such matters where the case is remanded back by the appellate authority or through the orders of the court, the Regional Director is authorized to issue restoration order pending re-consideration of the withdrawal order.
- NOW THEREFORE, In terms of above decisions taken by WRC and Appellate Authority the said recognition granted to the above institution viz. MARATHA SHIKSHAN SANSTHA, PLOT NO-281 KAKADDHARA, VILL-TALEGAON, WARDHA, MAHARASTHRA for conducting B.Ed. programme of two years duration with an annual is hereby restored
