CONTINUED ORDER

WHEREAS, recognition was granted to the institution namely, GYANODAYA MAHAVIDHYALAYA, F-SECTOR, MIG COLONY, KHAJRANI, INDORE, MADHYA PRADESH under section 14(1) of the NCTE Act, 1993 for conducting B.ED.(CO.ED) course of one year duration with an annual intake of 100 (SEC) (two basic Units of 50 students each) vide order No. WRC/5-6/99th/2007/C-21406-21408 dated 06.01.2007.

AND WHEREAS, the revised recognition order was issued to GYANODAYA MAHAVIDHYALAYA, F-SECTOR, MIG COLONY, KHAJRANI, INDORE, MADHYA PRADESH vide order No. WRC/APW0 5499/223586/2015/146644,49,51,52,54,56,61,64,65 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its 255th meeting held on 22-24 June, 2016 and the Committee decided "...issued Show Cause Notice to the institution of the condition maintained in revise order"

AND WHEREAS, a Show cause notice was issued to the institution on 06.10.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order.

1) Staff Profile for the session 2015-2016 duly approved by the affiliating body.

2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the matter was placed in 305th Meeting held on April 15-16, 2019 and the Committee decided that ". The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 31/05/2015. The Show Cause Notice was issued to the institution 06/10/2016. The institution has submitted reply of Show Cause Notice 21/11/2016.

On perusal of the reply of the institution it is observed that the institution has not submitted the following documents:

 The institution has not submitted a letter of approval of faculty of affiliating body along with detailed staff profile approved by competent authority of the University as per NCTE Regulations 2014.

The institution website found functional but contents not as per clause 7(14)(i) of NCTE Regulations, 2014.

• The institution has not submitted land use certificate issued by the competent authority.

The institution has not submitted NEC issued by the competent authority.

• The institution has submitted FDRs Rs. 5+4 lakhs in original and photocopy of 3 lakhs FDR.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order

AND WHEREAS, the Withdrawal order was issued to the institution on 08.01.2018.

AND WHEREAS, the matter was placed in 307th Meeting held on May 30th -31st , 2019 and the Committee decided that "... In view of the direction of the Hon'ble High Court of Delhi in W.P. No. (C) 5064/2019 and C.M. NO. 22439, 22440, 22441/2019, order dated 18/04/2019 at point No. 17 , decision WRC about the withdrawal order stands stayed and be allowed to continue to function. Accordingly, website be updated. However, other directions in the decision of the Hon'ble High court stand."

AND WHEREAS, the institution has filed an appeal to NCTE, Hqrs on 15.05.2019, "The Appellate Authority vide its appealed order dat. 05.07.2019 remand back the case to the WRC, NCTE for necessary action.

AND WHEREAS, the matter was placed in 309^{th} Meeting held on July 23rd - 26^{th} , 2019 and the Committee decided that " The appellate authority remanded back the case to WRC vide order dated 05/07/2019.

The committee considered the observations of appellate authority and the reply submitted by the institution vide letter dated 11/07/2019 and observed that:

 The institution is required to submit latest staff profile along with letter of approval in original.

Hence, the committee decided to confer last opportunity to the institution to submit the above within 30 days failing which recognition will be withdrawn under section 17 of NCTE Act, 1993.

AND WHEREAS, the Matter was considered by WRC in its 321st Meeting held on 09th and 11th November 2020 and WRC decided (Ref: Sl. No. 49, Page No. 36-37 of 321 WRC Minutes) as under:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under"

Recognition of the institution be continued for the B.Ed programme

NOW THEREFORE, the recognition of **GYANODAYA MAHAVIDHYALAYA**, **F- SECTOR**, **MIG COLONY**, **KHAJRANI**, **INDORE**, **MADHYA PRADESH** for conducting B.Ed. **(CO.ED)** course with an with an annual intake of 100 (**SEC**) (two basic Units of 50 students each) is permitted to continue Recognition order with an annual intake of 100 students (two basic units).
