AND WHEREAS, the inspection letter was issued to the VT members & institution online on 28/06/2018 and the inspection was conducted in its new premises of the institution on 03-07-2018. VT inspection report received in WRC on 04.07.2018 with CD.

AND WHEREAS, the visiting team report along with other documents was placed in 297th Meeting of WRC held on September 13-14, 2018 and the Committee observed that "This is a case of shifting.
