Whereas in terms of Section 14(1) of the NCTE Act, 1993, CALORX INSTITUTE OF EDUCATION, (CONSTITUTED UNIT OF CALORX TEACHERS UNIVERSITY), SURVEY NO. 1483, NR. GREENWOOD RESORT, POST- OGNAJ AHMEDABAD-382481, GUJARAT, (Code No. - 323595) had submitted an application on 02.11.2010 to the Western Regional Committee of the NCTE for grant of recognition B.Ed. (Innovative Curse) course of 18 months duration with an annual intake of 100 seats.

- 2. And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, laboratory and that it fulfills such other conditions required for proper functioning of the institution for B.Ed. (Innovative course), as determined by clause 7(9) of NCTE Regulations, 2009, and decided to issue letter of intent dt. 13.01.2014.
- 3. And whereas, reply dated 03.02.2014 submitted by the institution was considered by WRC in its 200th meeting held on February 5 -7, 2014 and committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper functioning of the institution for B.Ed. (Innovative course) course, as determined by the NCTE Regulations 2009.
- 4. Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to CALORX INSTITUTE OF EDUCATION, (CONSTITUTED UNIT OF CALORY TEACHERS UNIVERSITY), SURVEY NO. 1483, NR. GREENWOOD RESORT, POST- OGNAJ AHMEDABAD-382481, GUJARAT (Code No. 323595), for starting B.Ed. (Innovative course) course of Secondary level of 18 months duration with an annual intake of 100 from the academic Session 2014-15.
- 5. Further, the institution is required to comply with all post-recognition conditions. enumerated from clause 8(11) to clause 8(16) of the NCTE (Recognitic. Norms & Procedure) Regulations 2009.
- 6. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its imbility to do so.
- 7. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session 2014 - 2015.

- The recognition will operate for 2014-2015 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affillating Body.
- 9. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
- 11. If, at any time, either on sue-motto inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the Rules, Regulations, Orders made or issued there under or any condition subject to which the recognition was granted, the recognition may be withdrawn under the provisions of section 17 (1) of the NCTE Act.
