AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached Regulations. therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 247th meeting held on April 04-06, 2016 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. AND WHEREAS, on serutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 247th meeting held on April 04-06, 2016 was satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. (part-time) programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

AND WHEREAS, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE granted permission to ORIENTAL UNIVERSITY, PLOT NO: 81/2,81/3 ETC., STREET: SANWER ROAD, VILLAGE: JAKHIYA, POST OFFICE: AUROBINDO, TEHSIL: SANWER, CITY:INDORE, DISTRICT :INDORE-453555, MADHYA PRADESH for conducting B.ED. (part-time) programme of 3 (Three) years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2016-17.

AND WHEREAS, the Recognition Order No. WRC/APP2533/223 (part-time)/247th/2016/165201, 204, 206, 208, 210, 212, 214 dated 20.04.2016 was issued to the institution for an annual intake of 50 students (one basic unit of 50 students).

AND WHEREAS, the institution filed appeal w/s 18 of the NCTE Act with the Council. The Council vide order No. F.No. 89-260/2016 Appeal/7th Meeting-2016/32512 dated 04.07.2016 remanded the case to the WRC with the following directions: "to consider the list of eight faculty members forwarded by the appellant with his letter dt. 11.04.2016 and take a fresh decision in the matter."

AND WHEREAS, the appellant, aggrieved by the decision of the W.R.C. to grant recognition for one unit only against their application for two units, filed a Writ Petition No. 2836/2016 before the Hon'ble High Court of Madhya Pradesh, Bench at Indore. The Hon'ble High Court in their order dt. 24,04,2016 disposed the Writ Petition by directing the respondent No. I/Appellate Authority to decide the appeal of the petitioner expeditiously, as early as possible and endeavour shall be made to decide it on or before 02.05.2016.

AND WHEREAS, the order was placed before the WRC in its 257th Meeting held on August 02-04, 2016 and the Committee observed that "... This is a case of Oriental University which went in Appeal, and vide Appeal order dt. 04/07/2016, the case has been remanded to WRC for taking a fresh decision in the matter. The operative part of appellate order is reproduced below:-

"... The Committee also noted that the WRC in their 247th meeting held on 4-6 April, 2016, noting that the appellant, in their reply to LOI submitted a list of one H.O.D. and 5 Assistant Professors, who are qualified and approved by the competent authority, decided to grant Recognition for one unit of B.Ed. (Part Time) course from the academic session 2016-2017. The Committee, further noted that the appollant, on the basis of the minutes of the WRCs 247th meeting, wrote to the WRC on 07.04.2016, stating that no reason was given for reducing the intake from two units to one unit and there might be a typographical mistake. The appellant wrote another letter to the WRC on 11.04.2016 and which was received on 13.04.2016, forwarding a fresh list of eight faculty members towards compliance of the LOI for grant of Recognition for an intake of 100 students i.e. two units. WRC however, issued Recognition order on 20.04.2016 for one unit only as per their decision taken on 4-6 April, 2016 ... "

"... The Committee is of the opinion that the WRC, having issued a letter of intent for two units and being in receipt of a list of eight faculty members from the appellant on 13.04,2016, in the interests of justice, should have reviewed their decision and if satisfied, issued an order granting Recognition for two units ...".

The records in the case were checked up. It is seen that the decision to recognize of B.Ed. (Part-time) was taken in the 247th meeting (April 4-6, 2016). At that time the applicant had submitted an approved list of one HOD and 5 Assistant Professors only. The Recognition order was issued on 20/04/2016. The grievance of the applicant is that though he had submitted an amended list which was received in the WRO on 13/04/2016, still the Recognition order was issued only for one unit.

It is noteworthy that the Regional Director can issue a Recognition Order (or any other order) only on the basis of decision of the WRC. Hence, even if the applicant submitted a revised list on 13/04/2016, the RD on his own could not have changed the decision of the WRC. A Regional Committee meeting is held once or twice a month depending on the need – number of cases which have to be considered. The Committee cannot meet every day for every case. This point is to be appreciated by the applicants, and all other authorities who function under the NCTE Act and Regulations.

The revised list submitted by the applicant was examined and found to be in order.

Hence, Recognition is granted for two units of B.Ed. (Part-time) course from the academic session 2016-2017."

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the recognition granted to ORIENTAL UNIVERSITY, PLOT NO: 81/2,81/3 ETC.,STREET:SANWER ROAD, VILLAGE: JAKHIYA, POST OFFICE: AUROBINDO, TEHSIL: SANWER, CITY:INDORE, DISTRICT:INDORE-453555, MADHYA PRADESH for conducting B.ED. (part-time) programme of 3 (Three) years duration is for an annual intake of 100 students (two units of 50 student each) from the academic session 2016-17. The other contents of the Recognition order No. WRC/APP2533/223 (part-time)/247th/2016/165201, 204, 206, 208, 210, 212, 214 dated 20.04.2016 remain unchanged.
