- 5. The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 6. The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- 7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- The institution shall be free to post additional relevant information. if it j) k)
