RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely to LATE SHRI LAXMANJI MOTGHARE, 02, KOSRA KANDA, TV. PAUNI, DIST-BHANDARA, MAHARASHTRA under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. Course, with an annual intake of 100 students (Two basic units of 50 students each) vide order No. APW02006/123291/WRC/5-6/90/2006/11866-80 dated 05.03..2007.

AND WHEREAS, Revised Recognition order was issued to LATE SHRI LAXMANJI MOTGHARE, 02, KOSRA KANDA, TV. PAUNI, DIST-BHANDARA, MAHARASHTRA vide order No.F.NO. WRC/APW02006/123291/2015/144102-144125 dated 31.05.2015 for B.Ed. of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.

AND WHEREAS, Compliance was not submitted as per regulations 2014.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause notice was issued to the institution on 02.01.2017 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

AND WHEREAS, the reply of show cause notice was not submitted by the institution. The institution has submitted a letter dt. 13.06.2018 with request to reduce the Intake from 100 students to 50 Students.

AND WHEREAS, the matter was placed in 294^{th} Meeting held on July 04-05, 2018 of WRC and the Committee decided that:

"... The case file was seen. The Management vide letter dated 13.06.2018 has requested to reduce 01 unit of the B.Ed. course.

Hence, reduction of one unit is permitted and the institution is required to submit latest staff list."

AND WHEREAS, a Conveying letter was issued to the institution on 21.08.2018 and its reply not received till date.

AND WHEREAS, the matter was placed in 300th Meeting held on December 17-18, 2018 of WRC and the Committee decided that::-

"... The case file was seen. As requested by the institution, one unit (50 seats) of the B.Ed. course (APW02006/123291) has been reduced.

However, the latest staff profile approved by the Registrar (post 2016) is required for issuing revised order for the existing one unit which is running in the institution.

Hence, compliance be submitted by the institution within one month."

AND WHEREAS, a letter was issued to the institution on 09.01.2019 and its reply was not received.

AND WHEREAS, the matter was placed in 310^{th} Meeting held on August19-21,2019 of WRC and the Committee decided that:

"... The clarification letter was issued to the institution vide letter dated 19/01/2019. The summary of the case submitted reveals that the institution has not submitted reply of Clarification.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, the Withdrawal order was issued to the institution on 04.09.2019.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 12635/2019 & CM APPL. 51620/2019 dt. 25.02.2020.

AND WHEREAS, the matter was placed in 317th Meeting held on September 28-30, 2020 of WRC and the Committee decided that:-

"...The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. No. 12365/2019 and CM Appl No. 51620/2019 and decided that the representative of the institution be given personal hearing in the next meeting of WRC.

The representative alongwith all the requisite documents be remain present in the next WRC meeting."

AND WHEREAS, a letter was issued to the institution on 19.10.2020.

AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 14683/2021 with CM APPL.46223/2021 dt. 20.12.2021 the operative part is produced here below:-

"...The petition is, therefore, allowed, and the NCTE is directed to issue an order of restoration of recognition. The petitioner will be permitted to permitted to participate in counselling and admit students for the year 2021-22 and fro subsequent years, until and unless a fresh withdrawal order is passes against it. The status of the petitioner as a recognised institution will also be reflected on the NCTE's website, and will be communicated by the NCTE to the petitioner's affiliating university as well as to the concerned State Government. The NCTE is directed to comply with these directions within one week."

NOW THEREFORE, recognition of the institution viz LATE SHRI LAXMANJI MOTGHARE, 02, KOSRA KANDA, TV. PAUNI, DIST-BHANDARA, MAHARASHTRA for B.Ed. course with an annual intake of 100 students (Two basic units of 50 students of each) is hereby restored.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dt. 31.05.2015.
