AND WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 1.12.2014.

REVISED RECOGNITION ORDER

WHEREAS, recognition was granted to the institution, namely, CITY PUBLIC COLLEGE OF EDUCATION, PLOT/KHASRA NO. 40MIN2, STREET NUMBER - SHADHORA, VILLAGE - MUHAL DHEHAR, POST OFFICE/TEHSIL/TALUKA - SHADHORA, TOWN/ ASHOKNAGAR, PIN CODE - 473330, MADHYA PRADESH (WRCAPP3426) for conducting B.Ed. Course with an annual intake of 50 students vide order dated 20.06.2016.

AND WHEREAS, it is informed that pursuant to the NCTE Act of 1993, the NCTE Rules of 1997 and the subsequent Regulations of the 2014, all Teacher Educational Institutions (hereafter TEIs) have to mandatorily comply with the Provisions of the NCTE Act, Rules and Regulations

AND WHEREAS, the Council show cause notice dated 22.09.2017 directed the WRC to consider the request of the institution for two units, whereas recognition order was issued for one unit. An examination of the file shows that the institution has applied for one unit as per affidavit. However, since the college is also running one unit of D.El.Ed course, the requirement of built-up area for two units B.Ed. course is 3500 sq.mts. As per Building Completion Certificate available in the file, the built-up area is 4180 sq.mts. The institution had submitted a staff profile of 1+15 at the time of initial recognition. However, the institution applied for one unit as per affidavit. Under these parts circumstamces, two units cannot be granted. Hence, clarification be obtained from the institution. Reply should be submitted within one month . Accordingly, Clarification letter was issued on 22.09.2017.

AND WHEREAS, the reply received from the institution was placed before WRC in its 293^{rd} meeting held on june 12-14, 2018 and the Committee observed that " ... This is a Court case. As directed by the Hon'ble High Court of Delhi the WRC has to decide the case within two months. The examination of the file shows that there are two affidavits, one dated 01.03.2016 whwrein the number of units requested was one. However, there in another affidavit dated 20.04.2016 wherein it requested for two units which is also confirmed by the VT. The institute has submitted a staff profile of 1+15. Hence, Recognition order be modified to two units from the session 2019-2020."

NOW THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the western Regional Committee, NCTE hereby grants recognition to CITY PUBLIC COLLEGE OF EDUCATION, PLOT/KHASRA NO. 40MIN2, STREET NUMBER - SHADHORA, VILLAGE - MUHAL DHEHAR, POST OFFICE/TEHSIL/TALUKA - SHADHORA, TOWN/ CITY/DISTRICT - ASHOKNAGAR; PIN CODE - 473330, MADHYA PRADESH for one additional unit of 50 (fifty) seats) in B.Ed. programme of 2 (Two) years duration thereby totaling to 50+50=100 (One hundred) students from the academic session 2019-2020 Alre
