WHEREAS, the recognition was granted to the institution namely SHRI KRISHNA TEACHERS TRAINING INSTITUTE, RUN BY LATE SHRI BALBEER SINGH GAUTAM SHIKSHA PRASAR AVAM JANKALYAN SAMITI, SATAI ROAD MAUJA GURAIYA, SATAI ROAD PAHADIYA, CHHATARPUR-471001, MADHYA PRADESH vide order dated WRC/5-6/123rd//2009/58702-58707 Dated 04.08.2009 for conducting D.ED. (H) (E) (CO-ED) course with annual intake of 50 students 31.10.2008.

- 2. AND WHEREAS, the institution has submitted an application of shifting premises & change of name from Shri Krishna Teachers Training Institute Run By Late Shri Balbeer Singh Sautam Shiksha Prasar Avam Jankalyan Samiti, Khasra No.- 334/1/1, 335/1/1, 338/2, 423, 426, Plo No.- 334, Street-Main Road, Vill-Guaraiya, P.O.- Chhatarpur, Tehsil-Chhatarpur, City- Chhatarpur, District: Chhatarpur-471001, Madhya Pradesh to Department of Education, Shri Krishana University, Khasra no. 139, Village-Budaur, NH-86, Sagar Road, Chhatarpur, Madhya Pradesh for Existing B.ED. (WRCAPP3071), D.EL.ED. (APW08064/222489), B.Sc.B.Ed. (WRCAPP2016600090 ID:9238) & B.A.B.Ed. (WRCAPP2016600089 ID:8771)
- 3. AND WHEREAS, the matter of B.ED., D.EL.ED., BSc.B.ED & B.A.B.ED. was considered in WRC in its 296^{th} Meeting held on 28^{th} - 29^{th} August 2018, the Committee decided as under:

"This is a case of shifting. Shri Krishna Teacher Training Institute has become a Private University. WRC has issued a letter dated 09.08.2018 confirming the same. The University has now applied for shifting from Village-Gauraiya to NH-86, Sagar Road, Budaur. The institution has also paid Rs.1.5 lakhs for the same.

Hence, VT be constituted to shift the institution and all its courses.

The University wants to convert the college to Department of Education of the University. The institution has already paid a sum of Rs.1.5 lakhs for the same. Hence, change of name from Shri Krishna Teacher's Training Institute to Department of Education under Shri Krishna Vishwavidyalaya is permitted.

The University has submitted an NOC dated 22.06.2018 from Maharaja Chhattrasal University, Chhatarpur, by which affiliation for the B.Ed., B.A. B.Ed., B.Sc. B.Ed. courses will now be with Shri Krishna Vishwavidyalaya. D.El.Ed. course will run under the Department of Education, Shri Krishna Vishwavidyalaya and the affiliating body will be Madhyamik Shiksha Mandal,Bhopal."

4. AND WHEREAS, the matter was considered in WRC in its 297^{th} Meeting held on 13^{th} - 14^{th} September 2018, the Committee decided as under:

... "WRC in its 295th meeting asked the University to obtain NOC from Rajya Shiksha Kendra to run the D.EI.Ed. course under the jurisdiction of the University. Rajya Shiksha Kendra vide vide letter dated 12.09.2018 has given NOC. Therefore, the University is permitted to admit students for the permitted 01 unit (50 seats) and conduct the examinations of the students under its jurisdiction"

- 5. AND WHEREAS the change of name order from Shri Krishna Teachers Training Institute to **Department of Education, Shri Krishana University, Chhatarpur, Madhya Pradesh** was issued to the institution vide order no. WRC/222489/D.EL.Ed/296th & 297th /2018/203873-203880 dated 07-06-2018.
- 6. AND WHEREAS, the inspection of shifting premises was conducted on 04.07.2019, the matter was considered in WRC in its 311^{th} Meeting held on September 25^{th} - 27^{th} , 2019 and the Committee decided as under:
- "...The original file of the Institution alongwith VTR of shifting premises , VCD & other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observation was made:-

All infrastructure is as per NCTE norms.

Hence the committee decided that shifting of premises and change of name is permitted."

11. Now, therefore, in exercise of the powers vested under section 8(9) of the NCTE, Regulations, 2014. The Western Regional Committee grants permission to change the name and premises from Shri Krishna Teachers Training Institute, Run By Late Shri Balbeer Singh Gautam Shiksha Prasar Avam Jankalyan Samiti, Satai Road Mauja Guraiya, Satai Road Pahadiya, Chhatarpur-471001, Madhya Pradesh to Department of Education, Shri Krishana University campus, N.H.86, Sagar Road, Village-Budaur, Khasra no. 139, Chhatarpur, Madhya Pradesh for conduct of D.ED.
