## **ORDER**

WHEREAS, In terms of under Section 15(3)(a) of NCTE Act, 1993 recognition was granted to the university namely, Gujarat Vidyapeeth, Ashram Raod, Ahmedabad-380014, Gujarat for M.P.Ed. course of two years duration with an annual intake of **10 students** vide Order No. WRC/5-6/29/2001/5137-43 dated 21.08.2001 from the academic session 2001-2002 and subsequently vide Order No. WRC/2-32/314013/68/2005/10314 dtd. 25.02.2005 with an annual intake of **30 students** from the academic session 2005-2006.

- 2. AND WHEREAS, University has submitted request to the office of WRC vide their letter No. 3/RO/2024-25 dtd. 08.04.2024 to revision/ re-fixation of intake granted for M.P.Ed. Course from 30 to 50 students being a single basic unit as per provision of Clause-3(3.1) of Appendix-8 of NCTE's Principal Regulation, 2014. But, this provision has expressed one basic unit of 40 (Forty) Students for each year for M.P.Ed. Course.
- 3. AND WHEREAS, the matter was placed before WRC in its 413<sup>th</sup> WRC meeting held on 27<sup>th</sup> to 29<sup>th</sup> January, 2025 and the Committee decided as under:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations, 2014 and Guidelines issued by NCTE from time to time and the Committee decided to allow the intake of 40 for the M.P.Ed. course as per request made by the University vide its letter dated 30.09.2024 as per Appendix 8 of Norms and Standards, NCTE Regulations, 2014.

4. NOW THEREFORE, the Western Regional Committee hereby grant permission the intake of **40 for M.P.Ed. Course.** The rest contents of the existing aforesaid recognition order dated 25.02.2005 for M.P.Ed. Course will remain unchanged.
