ORDER

In terms of Section 14 (1) of the NCTE Act, 1993 SUBHASH CHANDRA BOSE COLLEGE, B-81-83, GOVINDPURI, NEAR JIWAJI UNIVERSITY, GWALIOR, MADHYA PRADESH had submitted an application to the Western Regional Committee of NCTE for grant of recognition for starting D.Ed. of two year from the academic session 2005 – 2006 with an annual intake of 50 students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - (i) The institution has acquired the land for setting up the teacher education institution.
 - (ii) The institution has constructed the building for conducting the course on the abovementioned land.

- The institution has made arrangements for conducting the course in rented premises.
- (iii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs.3.00 lakhs.
- (iv) The institution has initiated the process for recruitment of Principal/Head of Department and teachers for the said course.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **SUBHASH CHANDRA BOSE COLLEGE**, **B-81-83**, **GOVINDPURI**, **NEAR JIWAJI UNIVERSITY**, **GWALIOR**, **MADHYA PRADESH** for **D.Ed.** of **two year** from the academic session **2005 2006** with an annual intake of 50 students subject to fulfillment of the following.
- (a) The institution shall ensure that it gets duly affiliated for this course to the concerned University and all other formalities required by the University are also completed before the commencement of the course and admission of the students to the course and a report to this effect should be sent to the Committee.
- (b) That the institution will ensure that 06 (one Principal and 05 lecturers) faculty members as per NCTE norms are in position for an intake of 50 students before commencement of the course and a report to this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (c) The institution shall within one month of the receipt of recognition create an endowment fund account into a joint account to be operated along with an official of the Regional Committee.

- (d) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).
- (e) The institution shall comply with the various other norms and standards as prescribed in the NCTE Regulations.
- 4. Recognition is subject to the condition that the affiliating University shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/State Government.
- 5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of Education to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

WHEREAS, recognition was granted to the institution, namely, SUBHASH CHANDRA BOSE COLLEGE, B-81, 83, GOVINDPURI, NEAR JIWAJI UNIVERSITY, GWALIOR-474011, MADHYA PRADESH under section 15 of NCTE Act, 1993 for conducting D.ED course of two years duration with an annual intake of 50 students from session 2005-2006 vide order No.WRC/2-32/222056/76/2005/6153 dated 09.08.2005.

AND WHEREAS, Madhyamik Shiksha Mandal, Bhopal vide letter dated 23.06.2014 & 24.07.2014 issued Show Cause notice to the institution before de-affilation of the institution and requested WRC, (NCTE) to take action in the matter.

AND WHEREAS, Madhyamik Shiksha Mandal, Bhopal vide letter dated 02.09.2014 & 20.10.2014, further requested WRC, (NCTE) to take action in the matter.

AND WHEREAS, the matter was placed before the WRC in its 211th meeting held on October 31, 2015 and the Committee decided as follows "...The restoration order of Recognition was issued to the institution on 25.09.2013. Subsequently, the Madhyamik Shiksha Mandal, Bhopal sent a series of letter dated 02.09.2014, 20.10.2014 to the NCTE to take action on the Show Cause Notice issued by them to the institution. The matter pertains to admission which comes under the purview of Board, if there is any violation of the NCTE norms, the same may be forwarded to the NCTE for further action." Accordingly, letter dated 10.11.2014 was sent to the Secretary, Madhyamik Shiksha Mandal, Bhopal.

AND WHEREAS, Madhyamik Shiksha Mandal, Bhopal, vide letter No. 2896/डी.एड. सेल/2015 dt. 10.07.2015 discontinued the affiliation of the institution, and requested WRC (NCTE), Bhopal to take action as per NCTE Regulations.

AND WHEREAS, the matter was placed before the WRC in its 253rd meeting held on May 24-26, 2016 and the Committee decided to issue Show Cause Notice to the institution on the following grounds:- "...The Madhyamik Shiksha Mandal, Bhopal M.P. vide letter dt. 22/12/2014 has informed the WRC that the institution under the name of Subhash Chandra Bose College (222056) in compliance to the interim Court Order dt. 13/08/2012 admitted students in D.Ed. course first year who were different from the list provided by the institution to the Court alongwith its petition. This is violation of the condition mentioned in the Recognition order that the institution shall follow all the requirements of affiliation and recognition. This matter was already communicated to the institution by the Madhyamik Shiksha Mandal vide Order dt. 10/07/2015. **Hence, Show Cause Notice be issued under section 17, on the above ground.**" Accordingly, Show Cause Notice was issued to the institution on 30.05.2016.

It has also been informed that the sponsoring Society has filed a Writ Petition in the Hon'ble High Court. AND WHEREAS, the institution preferred an appeal before the Council (NCTE) u/s 18 of NCTE Act, 1993, against the Withdrawal order dated 29.07.2016 and the Council vide order dated 10.08.2017 remanded the case to WRC with a direction to take necessary action for restoration of recognition for conducting D.Ed. course by the appellant institution.

AND WHEREAS, the aforesaid appeal order was placed before the WRC in its 280th meeting held on August 31-September 1, 2017 and the Committee decided that "...Recognition was withdrawn to the institution on 29.07.2016 on the ground that there was difference in the names of students who are admitted to the D.Ed. Ist year vis-à-vis the list submitted to the court. Subsequently the institute informed that this was the result of a clerical error. Further, Madhyamik Shiksha Mandal vide letter dt. 26.04.2017 has stated that it would have no objection for the continuance of the course if the WRC restores recognition. This is a same stand taken by the appeal committee. The institute should submit the latest list of faculty approved by the competent authority. The letter referred to in the appeal order of Madhyamik Shiksha Mandal dt. 28.04.2017 should be obtained from the Board of Secondary Education, Bhopal. Thereafter, the case will be process further. "Accordingly, letter was issued to the institution on 07.09.2017.

AND WHEREAS, reply submitted by the institution was placed before WRC in its 281st meeting held on September 19-20, 2017 and the Committee decided as follows "...The institute was asked to submit the latest list of faculty approved by the competent authority. The institute has now done so. **Therefore, Recognition is restored."**

NOW, THEREFORE, the Western Regional Committee hereby restores the recognition to SUBHASH CHANDRA BOSE COLLEGE, B-81, 83, GOVINDPURI, NEAR JIWAJI UNIVERSITY, GWALIOR, MADHYA PRADESH for conducting D.Ed. Course with an annual intake of 50 seats with the same terms and conditions as mentioned in the recognition order dated 09.08.2005.
