





1. The petitioner has approached this Court seeking the following reliefs:-

"(a) issue a writ of mandamus or any other appropriate writ or order directing the Respondents to issue an order or corrigendum or clarification letter mentioning therein the status of petitioner institution as an already recognized institution for running the D.Ed. course with approved intake of 100 seats and to upload the said corrigendum or clarification letter on their website with further communication of the same to Madhya Pradesh Board of Secondary Education and the State Council for Educational Research & Training; and/or

(b) pass any such other or further order(s) or direction(s) as this Hon'ble Court may deems fit & proper in the facts & circumstances of the instant case and also in the interest of justice & equity"

2. Learned counsel for the petitioner submits that even though it is an admitted position that the petitioner is a recognised institution for the

purpose of running D.Ed course with an intake of 100 students due to some confusion in the information provided on the respondents' website, the students are finding it very difficult to comprehend that the petitioner continues to be a duly recognised institute for 100 seats in D.Ed.

- 3. Issue notice. Learned counsel for the respondent accepts notice and while submitting that the information available on the website is clear, fairly submits that the respondent has no objection in issuing a further clarification to the effect that the petitioner is a recognised college for running D.Ed course with an intake of 100 students.
- 4. In light of the aforesaid stand taken by the learned counsel for the respondent, the writ petition is disposed of by directing the respondent to publish on its website, a clarificatory notice that the petitioner is, as on date, a recognized institute for 100 seats in D.Ed and forward the same to the affiliating board within a period of two weeks from today.
