Withdrawal Order U/S-17 534, 535, 536, 537

WHEREAS, recognition was granted to the institution, namely, **SHRIYUT SHIKSHAN SAMITIS, SHRIYUT COLLEGE, GANGEO, CITY: REWA, MADHYA PRADESH** vide order No. WRC/5-6/44/2003/1986-1992 dated 02.05.2003 for **B.ED. (CO-ED)** Course with an annual intake of 100 students.

AND WHEREAS, One Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 16.09.2015.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 21.01.2015.

AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on **31.05.2015**.

AND, WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the WRC in its **255th meeting held on 22-24 June, 2016** and the Committee decided "... issue Show Cause Notice to the institution of the condition maintained in revised order."

AND, WHEREAS, a Show cause notice was issued to the institution on **27.07.2016** for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure the institution reply was submitted on dated. **30.03.2017**.

AND WHEREAS, the matter was placed in **285th meeting of WRC held on December 19-21, 2017** and the Committee decided that "... In response to the Show Cause Notice dated 27.07.2016, the institution has not submitted approved staff profile.

Building Completion Certificate not submitted in the prescribed format

FDRs of Rs.4.00 lakhs (in joint name) not submitted in original.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs if any, be returned"

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
