## WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely MAA SHARPA EDU CATIONAL INSTITUTE CHHATARPUR SAMITI, KHASRA NO. 869, VILLAGE: GATHEORA, STREET/ROAD: PANNA ROAD, TALUKA/MANDAL: CHHATARPUR, TOWN/CITY: CHHATARPUR, CISTRICT: CHHATARPUR-471001, MADHYA PRADESH vide Order No. WRC/APP2016602 9-A/983 /B.El.Ed./ M.P./289<sup>th</sup>/2018/196047, 048, 049, 050, 051, 052, 053, 054 dated 05.03.2018 fo B.El.Ed. course of 4 (four) years duration with an annual intake of one unit (s) of 50 students.

AND WHEREAS, the NCTE Hqrs. vide letter No. 68759 dated 02.08.2018 as directed the WRC to reconsider the cases where recognition was granted to institutions which had staff members who were not qualified for want of Ph.D./NET w.r.t. NCTE notification published on 09.06.2017.

AND WHEREAS, the WRC reconsidered the matter in the light of NCTE Hars, letter no.\68759 dated 02.08.2018 in its 296th meeting held on August 28-29, 2018 and the committee decided that the "...WRO is directed to issue Show Cause Notice in this regard w.r.t. letter No.68759 dated 02.08.2018 received from NCTE Hars. The institution should reply within one month.

A re-examination of regulatory file shows that the Assistant Professor (s)/Lecturer (s) do not have Ph.D. or NET/SET.

AND WHEREAS, Accordingly, Show Cause Notice was issued to th€ institution dt. 27.09.2018. The institution has not submitted reply of Show Cause Notice. The matter was considered by the WRC in its 309th meeting held on July 23-26, 2019 and the Committee decided as under:-

"The Show Cause Notice was issued to the institution vide letter dated 27.09.2018. The reply of the Show Cause Notice of the institution has not been received.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.El.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, Accordingly, Withdrawal order was issued to the institution dt. 08.08.2019.

AND WHEREAS, the institution has filed an appeal NCTE, Hgrs. on 04.10.2019. The Appellate Authority vide its order dated 05.12.2019 remanded back the case to the WRC, NCTE, with the direction to the institution to submit the list of faculty approved by affiliating university to WRC within 15 days of the issue of appellate order. Till date the institution has not complied with the direction of the appellate authority.

AND WHEREAS, the matter was placed in 313th Meeting held on February 25th-27th, 2020 of WRC and the Committee decided that:-

"The Committee considered the matter keeping in view the order of the Appellate Authority dated 05.12,2019 and decided as under:-

Speaking order for withdrawal of recognition be issued."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby Withdraws recognition of MAA SHARDA EDUCATIONAL INSTITUTE CHHATARPUR SAMITI, KHASRA NO. 869, VILLAGE: GATHEORA, STREET/ROAD: PANNA ROAD, TALUKA/MANDAL: CHHATARPUR, TOWN/CITY: CHHATARPUR, DISTRICT: CHHATARPUR-471001, MADHYA PRADESH granted for B.El.Ed. course on the grounds mentioned above from the end of the academic session next following the date of communication of the said order.
