ORDER

WHEREAS, the recognition was granted to the institution namely **Maa Sharda Educational Institute Chhatarpur Samiti, Khasra No. 869, Village-Gatheora, Street/Road-Panna Road, Taluka/Mandal-Chhatarpur, Town/City-Chhatarpur, District-Chhatarpur-471001, Madhya Pradesh** for **B.El.Ed.** programme of **4 (four) years** duration with an annual intake of **50 students (One basic unit)** Vide Order No. WRC/APP201660209-A/9839/B.El.Ed./M.P/289th/2018/196047-196054 dated. 05.03.2018.

2. **AND WHEREAS**, the NCTE Hqtr. Vide letter No. 68759 dated 02.08.2018 has directed the WRC to reconsider the case where recognition was granted to the institutions which had staff members who were not qualified for want to Ph.D./NET w.r.t. NCTE notification published dated 09.06.2017.

3. **AND WHEREAS**, the WRC reconsidered the matter in the light of NCTE Hqrs. Letter No. 68759 dated 02.08.2018 in its 296th meeting held on August 28th -29th August 2018 and the Committee decided that the "...who is directed to issue Show Cause Notice in this regard w.e.t. letter No.68759 dated 02.08.2018 received from NCTE Hqrs. The institution should reply within one month." A re-examination of the regulatory file received that the Assistant Professor(s) Lecturer (s) do not have Ph.D. or NET/SET.

4. **AND WHEREAS**, accordingly, Show Cause Notice was issued on 27.09.2018 to the institution. The institution has not submitted reply of Show Cause Notice. The matter was considered by the WRC in its 309th meeting held on 23rd -26th July, 2019 and the Committee decided as under: -

"The Show Cause Notice was issued to the institution vide letter dated 27.09.2018. The reply of the Show Cause Notice of the institution has not been received.

Hence, the Committee decided to withdraw the recognition under Section 17 (1) of the NCTE Act, 1993 for B.El.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

5. **AND WHEREAS**, as per decision of the Committee withdrawal order was issued to the institution Vide Order No. WRC/APP201660209-A/9839/309th/B.El.Ed./2019/205257-205664 dated 08.08.2019.

6. **AND WHEREAS**, the institution has filed an appeal NCTE, Hqrs. on 04.10.2019. The Appellate Authority vide its order dated 05.12.2019 remanded back the case to the WRC, NCTE, with the direction to the institution to submit the list of faculty approved by affiliating University to WRC within 15 days of the issue of appellate order. The institution was not complied with the direction of the appellate authority.

7. **AND WHEREAS**, the matter was placed in WRC in its 313th meeting held on 25th -27th February 2020 and the Committee decided that: -

"The Committee considered the matter keeping in view the order of the Appellate Authority dated 05.12.2019 and decided as under: -

Speaking order for withdrawal of recognition be issued.

8. **AND WHEREAS**, accordingly, withdrawal order was issued to the institution Vide Order No. WRC/APP201660209-(A)/9839/313th/(M.P)B.El.Ed./2020/208655-208662 dated 23.06.2020.

9. **AND WHEREAS**, aggrieved by the order of the WRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-161/E-162401/2020/Appeal/25th Mtg.-2020/26th dated 27.11.2020 appeal remanded back the case to the WRC, NCTE for revisiting the matter after appellant institution submits within 15 days of the issue Appeal order the revised list of faculty.

10. **AND WHEREAS**, the matter was placed WRC in its 329th meeting held on 17th -19th February 2021 and the Committee decided that: -

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act. 1993. Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

1. *The Staff list has the counter signed of the Approving Authority which is not acceptable.*
2. *The institution is required to submit latest Staff list duly approved by the Approving Authority of the concerned affiliating body clearly indicating the seal and signature of the Approving Authority along with faculty approval letter issued by the concerned affiliating body.*

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for B.El.Ed programme."

11. **AND WHEREAS**, Final Show Cause Notice was issued to institution dated 11.03.2021. The institution has submitted reply of Final Show Cause Notice vide letter dated 04.04.2021, 04.05.2024, 21.05.2024 & 30.08.2024.

12. **AND WHEREAS**, the institution vide letter No. 1545 dated 26.05.2025 received in the office of WRC dated 27.05.2025 and 05.06.2025 has attached copy of order passed by Hon'ble High Court of Delhi in WP (C) No. 4753/2025 dated 21.05.2025 along with copy reply of Show Cause Notice dated 11.03.2021. The operative part of the order of Hon'ble Delhi High Court dated 21.05.2025 is as under: -

"4. Mr. Akhilesh K. Srivastava learned Standing Counsel appearing on behalf of the respondent/NCTE submits that he has no objection in case a similar order is passed in the present petition.

5. In view of the above, it is clarified that the remand order dated 27.11.2020 would also be treated as quashing the withdrawal order dated 23.06.2020 as well.

6. At this stage, Mr. Srivastava submits that a show cause notice was issued by the respondent/NCTE on 11.03.2021 to which reply has not been submitted by the petitioners.

7. Mr. Amitesh Kumar submits that reply to the said show cause notice has been submitted on 04.04.2021 through speed post, however, a copy of the same will again be furnished to the respondent/NCTE within a period of one week from today.
8. Accordingly, the WRC is directed to pass the order of restoration in favour of the petitioner institution for recognition of the concerned course in accordance with law within a period of two weeks from today. The said order shall remain subject to further decision to be taken by the WRC.
9. A copy of the order of restoration of recognition of the petitioner institution for the concerned course will have to be communicated to all concerned. Once the order of restoration is passed, the petitioner institution would be entitled to participate in counseling and admission process for the Academic Year 2025-26 and subsequent years.
10. The writ petition is disposed of in the aforesaid terms."

13. **AND WHEREAS**, the matter was placed in WRC in its 425th meeting held on 29th -30th May, 2025 and the Committee decided that: -

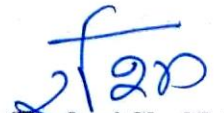
"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

As per the order of Hon'ble High Court of Delhi in WP (C) No. 4753/2025 dated 21.05.2025, the recognition of the B.El.Ed. course is restored."

"NOW, THEREFORE, the Western Regional Committee hereby restores recognition of Maa Sharda Educational Institute Chhatarpur Samiti, Khasra No. 869, Village-Gatheora, Street/Road-Panna Road, Taluka/Mandal- Chhatarpur, Town/City-Chhatarpur, District-Chhatarpur-471001, Madhya Pradesh for B.El.Ed. programme 4 years duration with an annual intake of 50 (one basic unit) i.e.50 students.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.

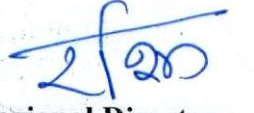
