RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely, SHRI MADHAVRAO WANKHEDE, SHARIRIK SHIKSHAN MAHAVIDYALAYA, BEHIND RLY STATION, KAMPTEE, TA.KAMPTEE, NAGPUR MAHARASHTRA (WRC/APW00746/114041) under section 14 of NCTE Act. 1993 for conducting B.P.ED. course vide order dated 28.08.1998 for an annual intake of 100 students.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institutions and the reply was received on 09.02.2015.

AND, WHEREAS, Revised Recognition order was issued for basic unit of 100 (one hundred) students with two sections of 50 (fifty) each to the institution on 31.05.2015.

AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... Follow up of Revised Orders for B.P.Ed. courses: The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item"

AND WHEREAS, the Show Cause Notice of compliance issued on 24.07.2017 and reply of compliance not received.

AND WHEREAS, the matter was placed in 290th Meeting held on March 21-23, 2018 of WRC and the Committee decided that "... Consequent to the issue of Revised Recognition order dated 31.05.2015 followed by a Show Cause Notice dated 24.07.2017. The institution has not replied so far.

Hence, Recognition is withdrawn from the end of the next academic session."

AND WHEREAS, the Withdrawal Order issued on 03.04.2018. The institution filed a appeal to the appellate authority.

AND WHEREAS, the appeal order dated 12.09.2018, "Appeal Committee concluded to remand back the case to WRC. Appellant institution is required to submit to W.R.C. (a) List of faculty approved by affiliating university (b) Building Plan, Building Completion Certificate (c) C.L.U. & Non Encumbrance Certificate within 15 days of the issue of Appeal orders and W.R.C. based on the merits of the case is required to revisit the matter and issue orders accordingly and expeditiously.

NOW THEREFORE, the Council hereby remands back the case of Shri Madhaorao Wankhade Sharirik Shikshan Mahavidyalaya, New Kamptee, Distt. Nagpur, Kamptee, Maharashtra to the WRC, NCTE, for necessary action as indicated above."

AND WHEREAS, the matter was placed in 297th Meeting held on September 13-14, 2018 of WRC and the Committee decided that "... Recognition was withdrawn vide order dated 03.04.2018. The institution went in appeal. The Appellate Authority vide order dated 12.09.2018 remanded the case to reconsider the case on the basis of the documents to be submitted by the institution. The institution vide letter dated 14.09.2018 has submitted a staff profile of one Principal, two Associate Professors and five Assistant Professors and other staff as required under as per Appendix-VI of NCTE Regulations, 2014. The institution has also submitted other documents as specified by the Appellate Authority.

Hence, Recognition is restored and permitted to continue."
