WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely MAJOR DHYANCHAND INSTITUTE OF PHYSICAL EDUCATION, BARKATULLAH UNIVERSITY, BHOPAL, MADHYA PRADESH vide Order no.WRC/2-32/02/2004/5078 dated 05.08.2004 for B.P.Ed. course of one year duration with an annual intake of 50 students.

AND, WHEREAS, the revised recognition Order was issued to the institution namely MAJOR DHYANCHAND INSTITUTE OF PHYSICAL EDUCATION, BARKATULLAH UNIVERSITY, BHOPAL, MADHYA PRADESH vide order No.WRC/214006/Revised order{M.P.}/2015/9105-9112 dt. 02.07.2015 for B.P.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16 with certain conditions.

AND WHEREAS, the institution has not complied with the conditions of revised recognition order. The matter was considered by WRC in its 255th meeting and Committee decided to issued Show Cause Notice u/s 17 of NCTE Act 1993.

AND WHEREAS as per decision of WRC Show Cause Notice was issued to the institution on 01.02.2017.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice dt 01.02.2017. The matter was considered by WRC in its 303rd meeting held on 26th-28th February, 2019 and the Committee decided to withdraw the recognition for B.P.Ed. programme from the academic session 2019-2020. under Section 17(1) of the NCTE Act, 1993 on the following grounds:-

• The Show Cause Notice was issued to the institution vide letter No. WRC/214006/255th meeting /MP/ 179526 -527 dated 01/02/2017.

The institution has not submitted reply of Show Cause Notice dated 01/02/2017 till date.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee hereby withdraws recognition of MAJOR DHYANCHAND INSTITUTE OF PHYSICAL EDUCATION, BARKATULLAH UNIVERSITY, BHOPAL, MADHYA PRADESH granted for B.P.Ed course on the grounds mentioned above from the academic session 2019-2020.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
