## FINAL SHOW CAUSE NOTICE

WHEREAS, recognition was granted to the institution namely MANDSAUR INSTITUTE OF PHYSICAL EDUCATION, RUN BY B.R. NAHATA SMRITI SANSTHAN, REWAS-DEWDA ROAD, MANDSAUR-458002, MADHYA PRADESH vide Order No.WRC/5-6/104th/2008/37873-37878 dated 29.07.2008 for B.P.Ed. course of one (1) year duration with an annual intake of one unit (s) of 50 students.

AND WHEREAS, the revised order was issued to the institution vide order no. WRC/APW05907/224153/Revised Order/ $\{M.P.\}/2015/136055$ , 56, 57, 58, 59, 60, 61, 62 dt. 20.05.2015 for conducting B.P.Ed. programme of two (2) years duration with an annual intake of 100 students (one unit with two sections of 50 (fifty each) from the academic session 2015-16.

AND WHEREAS, the institution has submitted Compliance of revised recognition order dt. 20.05.2015.

AND WHEREAS, the matter was considered in WRC in its 255<sup>th</sup> meeting held on June 22-24, 2016 and the Committee decided to issue SCN on the following points:-

> Original Staff Profile (1-Principal/HOD+15 Faculties) from the session 2016-2017 duly approved by the affiliating body.

> Originally notarized (not Xerox) CLU, NEC, Building plan and Building Completion Certificate.

AND WHEREAS, Show Cause Notice was issued to the institution on 01.02.2017.

AND WHEREAS, the institution has not submitted reply of SCN dated 01.02.2017. The matter was considered in WRC in its  $301^{\rm st}$  meeting held on January 17-18, 2019 and the Committee decided as under:-

"Show Cause Notice was issued to the institution on 01.02.2017 and reply has not been received till date. Hence, Recognition is withdrawn from the academic session 2019-2020. FDRs, if any, be returned."

AND WHEREAS, withdrawal order was issued to the institution dt. 23.01.2019. The institution has filed an appeal to NCTE Hqrs against withdrawal order dt. 23.01.2019 and the Appellate Authority passes an order dt. 03.06.2019. The institution has submitted reply dt. 13.06.2019. The matter was considered by the WRC in its 309<sup>th</sup> meeting held on July 23-26, 2019 and the Committee decided as under:-

The appellate authority remanded back the case to WRC vide order dated 03/06/2019.

The committee considered the observations of appellate authority and the reply submitted by the institution vide letter dated 13/06/2019 and observed that:

- The institution has submitted staff profile not approved by the affiliating university for which recognition for B.P.Ed. course was granted vide revised order dated 20/05/2015.
- The B.C.C. for survey No. 165/2 issued on 18/03/2019 and diversion order dated 10/10/2003 is issued for the purpose of Pharmacy college.
- The land for survey No. 165/2.

Hence, show cause notice under clause 17(1) of NCTE Act, 1993 be issued to the institution to submit the above within 30 days from the date of issue of show cause notice.

AND WHEREAS, Show Cause Notice was issued to the institution on 08.08.2019 & reply of Show Couse Notice received dt. 06.09.2019.

AND WHEREAS, the institution has filed W.P. 9012/2019 in the High Court of Delhi, Bench at New Delhi passed an order dt. 20.08.2019.

AND WHEREAS, the institution has submitted reply on 01.10.2019. The matter was considered by the WRC in its 314<sup>th</sup> meeting held on July 13-15 & 22, 2020 and the Committee decided as under:-

"The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. No. 9012/2019 and observed as under:-

- This is a case of revised recognition order and as well as change of affiliating body
- Mandsaur University is private university and is not empowered to affiliate any other institution except its Department of Education.
- As per submitted staff list principal is not qualified as he does not possess required 55 % marks in the Masters Degree.
- Faculty at Sr. No. 06, 07, 08, 10 and 11 are not qualified as they do not have required NET / Phd degree as per amended Regulation dated 09.06.2019.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act"

NOW THEREFORE, the institution is required to submit compliance accompanied with an affidavit from the authorized compliance of the Management. The compliance along with an affidavit must reach this office within 30 days of the issue of this Notice. In case, the office does not receive any compliance within stipulated time, it will be presumed that the institution does not wish to make any compliance, and the Western Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
