REVISED RECOGNITION ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, MARUTI SHIKSHA AVAM SWASTHA SAMITI, PLOT NO- 356, STREET: WARD NO-32, DHAWARI GALI NO-01, POST OFFICE- SATNA, CITY- SATNA, TEHSIL- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH (WRCAPP3495/223) had submitted on 13-07-2015 the application to the Western Regional Committee of the NCTE for grant of recognition to MARUTI COLLEGE OF EDUCATION RUN BY MARUTI SHIKSHA AVAM SWASTHA SAMITI, PLOT NO- 343/2, STREET- MAHADEVA, VILLAGE- MAHADEVA, POST OFFICE- MAHADEVA, TEHSIL- RAGHURAJ NAGAR, CITY- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH for B.ED. Course.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 275th meeting held on May 01-02, 2017 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to MARUTI COLLEGE OF EDUCATION RUN BY MARUTI SHIKSHA AVAM SWASTHA SAMITI, PLOT NO- 343/2, STREET- MAHADEVA, VILLAGE- MAHADEVA, POST OFFICE- MAHADEVA, TEHSIL- RAGHURAJ NAGAR, CITY- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH for conducting B.ED. programme of 2 (Two) years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2017-18.

AND WHEREAS, the Recognition Order No. WRC/APP3495/223/275th/2017/184891-898 dated 04.05.2017 was issued to the institution for an annual intake of 50 students (one basic unit of 50 students).

AND WHEREAS, the institution filed a Writ Petition (C) No. 3995/2018 before the Hon'ble High Court of Delhi at New Delhi. The Hon'ble High Court in their order dt. 03.05.2018 "the respondents are directed to treat the present writ petition as a representation and decide the same by passing a reasoned and speaking order within six weeks."

AND WHEREAS, the order was placed before the WRC in its 293rd Meeting held on June 12-14, 2018 and the Committee observed that "...This is a Court case. As directed by the Hon'ble High Court of Delhi the WRC has to decide the case within two months.

The institute has submitted a list of additional 8 faculty members who are qualified and approved by the competent authority.

Hence, Recognition order be modified to two units from the session 2019-2020."

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the recognition granted to MARUTI COLLEGE OF EDUCATION RUN BY MARUTI SHIKSHA AVAM SWASTHA SAMITI, PLOT NO- 343/2, STREET- MAHADEVA, VILLAGE- MAHADEVA, POST OFFICE- MAHADEVA, TEHSIL- RAGHURAJ NAGAR, CITY- SATNA, DISTRICT: SATNA- 485001, MADHYA PRADESH for conducting B.ED. programme of 2 (Two) years duration is for an annual intake of 100 students (two units of 50 student each) from the academic session 2019-2020. The other contents of the Recognition order No. WRC/APP3495/223/275th/2017/184891-898 dated 04.05.2017 remain unchanged.
