WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, Women Teacher Training College, Veer Durga Das Nagar, Pali, Rajasthan vide order No. F.NRC/NCTE/F-7/RJ-623/7798-7807 dated 08.11.2006 for B.Ed. course of one year duration with an annual intake of 100 students followed by order permitting change of name of institution to "Smt. Rukma Devi Mahila Shikshak Prashikshan Mahavidyalaya, Veer Durga Das Nagar, Pali, Rajasthan vide order No.NRC/NCTE/F-7-3/RJ-623/2009/3718-3724 dated 03.06.2009 and corrigendum vide No.NRC/NCTE/F-7-3/RJ-623/2009/3883-3889 dated 05.06.2009.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014 the institution by consented to come under new Regulation by affidavit and the Revised Provisional Recognition Order (RPRO) was issued to the institution 12.06.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 student (two basic units) from the academic session 2015-2016.
- **3. AND WHEREAS**, recognition for B.Ed. course was withdrawn vide Order F.No.WRC/NCTE/RJ-623/B.Ed./321st/2020/212692-212697 dated 14.12.2020 on the grounds mentioned therein.
- 4. AND WHEREAS, being aggrieved, the institution had filed an appeal and Appellate Authority vide order dated 02.06.2021 remanded back the case to WRC with direction to WRC to consider the reply of appellant institution which is required to be submitted again by the appellant to WRC within 15 days of the issue of appeal order.
- **5. AND WHEREAS**, recognition for B.Ed. course was withdrawn vide Order No.216977 to 216982 dated 14.08.2021 on the grounds mentioned therein.
- 6. AND WHEREAS, the institution filed writ petition in W.P. No. 10018/2021 in the Hon'ble High Court of Delhi at New Delhi and Hon'ble Court has passed Order dt. 10.09.2021 permitting the institution to participate in the counselling and admitting students for the academic year 2021-22 with direction to WRC to correct the status of the petitioner on its website and also communicate the same to the affiliating University of the petitioner and the concerned State Government, within one week from today. Accordingly, court order was complied by WRC vide order dated 05.10.2021 followed by corrigendum dated 05.10.2021 related to counselling.

- 7. AND WHEREAS, the appellant had preferred another appeal against the withdrawal order dated 14.08.2021 and Appellate Authority in consideration of the case presented by the Appellant passed an order dated 31.08.2023 and remanded back the case to WRC with a direction to constitute Visiting Team as per provisions of the NCTE Act, Rules & Regulations to verify the infrastructural and instructional facilities available with the institution and further to verify the documents submitted from the concerned issuing authority submitted in appeal which are required to be sent to them by appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal.
- **8. AND WHEREAS**, the matter was considered by WRC in its 394th Meeting held on 15th September, 2023, wherein the Committee decided as under:

"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

In compliance of order dated 31/8/2023 of the appellate committee, the WRC decides as follows:-

- i. Restoration order for B.Ed. Course be issued subject to further consideration of WRC.
- ii. VT be constituted under section 13 of the NCTE Act, 1993 for inspection of the institution to check the Infrastructural and instructional facilities available in the institution and facilities and documents etc.
- iii. Institution be directed to submit documents within 15 days in compliance of appeal order dated 31/08/2023.

Orders/letters be issued accordingly and be uploaded on NCTE website."

Accordingly, the Restoration Order was issued to the institution on 19.09.2023.

- **9. AND WHEREAS,** the Visiting Team under Section 13 of NCTE ACT, 1993 has been constituted by NCTE HQ and virtual inspection of the institution was conducted on 02.05.2024 and Visiting Team has submitted its report on 02.05.2024.
- 10. AND WHEREAS, the matter was placed in its 404th Meeting of WRC held on 21st and 22nd May, 2024 and the Committee decided as under:-

"The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- 1. In compliance of order dated 31.08.2023 of the appellate committee, inspection of the institution w/s 13 was conducted on 02.05.2024 through virtual mode.
- 2. On consideration of visiting team report dated 02.025.2024 along remarks of visiting team members recorded therein, the Committee observed that institution is still deficient on the following grounds:
 - Document related to permission of land use/Land Use Certificate (CLU) for educational purpose is not properly presented to VT members.



- Document related to Non-Encumbrance Certificate (NEC) is not presented to VT members.
- iii. Building plan is not prepared by registered Architect.
- iv. Document related to building constructed as per National Building Code and the same is fully safe and structurally sound having load bearing capacity as per the Code/Standards, to run the teacher training course is not presented to VT members.
- v. Building Safety certificate as per National/State Disaster Management Authority issued by competent authority is not presented to VT members.
- vi. Safeguard against fire hazard in all parts of building is not shown to VT members.
- vii. Information related to institution's campus, building, furniture etc. being barrier/accessible is not presented to VT members.
- viii. Building Completion Certificate and floor wise built up area mentioning therein is not accepted by VT members.
- ix. The college campus lacks accessibility features viz. lift, ramp, divyang toilets (there is only one toilet in the entire 4-storied building of the college).
- x. Most of the land documents were unclear and could not be viewed properly (during online presentation by the college team).
- xi. Latest approved faculty list by the affiliating body needs to be provided.

In view of the above, the Committee has decided that show cause notice u/s 17 be issued to the institution giving 21 days to submit reply for further consideration of WRC."

Accordingly, Show Cause Notice u/S 17 was issued to the institution dated 03.07.2024. The institution has submitted a reply vide letters dated 02.07.2024 on the website and subsequent letter dated 22.07.2024

11. AND WHEREAS, the matter was considered by WRC in its 408th (Part-I) Meeting held on 12th -14th November 2024 and the Committee decided as under:

"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- i. The institution has submitted the colour photocopy of CLU certificate dated 05.02.2021 signed by Patwari, Dist.- Pali, Rajasthan. Total built-up area mentioned as 2038 sqm. Total land area is not mentioned. As per VT remarks, the land is on private lease having total land area 1694.58 sq. mts. which less as per NCTE norms for 100 intake (two units) of B.Ed. course.
- ii. The institution has not submitted the latest Non-Encumbrance Certificate and indicating the Khasra No. and total area of the land.
- iii. The institution has submitted Building Plan signed/approved by PWD Engineer and Architect without showing date of approval. The same is not certified by Local Government. Khasra No. is not shown in the building plan.



- iv. Submitted Fire Safety Certificate issued by Fire Chief Officer, Pali, Rajasthan vide letter No. Fire/2024/4192 dated 02.05.2024 having general mistakes in the Hindi language. No Khasra/Plot No. and total area of the land has been mentioned in the NOC. The institution has not submitted copy of online fire certificate issued by LSG portal of Govt. of Rajasthan.
- v. Submitted Building Completion Certificate with floor wise issued by Junior Engineer Municipal Corporation, Pali, Rajasthan signature without date. Total land area mentioned as 1694.58 sq. mts. which is less against required 2500 sq. mts. and built-up area 2038.92 sq. mts. date of construction in 2016. As per VT remarks dated 02.05.2024, one school is running on the same patch of land but in a separate building.

vi. With regard to point regarding the college campus lacks accessibility features viz. lift, ramp, divyang toilets (there is only one toilet in the entire 4-storied building of the college, the institution mentions that these facilities are under construction.

- vii. With regard to point raised that most of the land documents were unclear and could not be viewed properly (during online presentation by the college team), the institution has not submitted land documents and attached copy of land possession certificate dated 05.02.2021 signed by Patwari, Pali mentioning that land bearing Chak No.2, total land area 6678 sq. mts. and allotted land area to the institution 3640 sq. mts. has been purchased from Nagar Vikash Nyas dated 09.02.1977 and related land document not attached.
- viii. With regard to point raised that Latest approved faculty list by the affiliating body needs to be provided, the institution submitted photocopy of faculty list comprising 01+15 faculties without approval of affiliating body. The faculty at Sl.no.1 namely Sh. Satya Prakash, Prospective in Education is not having PG in Social Science or PG (M.A) degree in education as per NCTE norms.

In view of the above, the Committee decided that Final Show Cause Notice u/s 17 be issued to the institution to remove the following deficiencies along with supporting/relevant documents affidavit by the management within 15 days from the date of issue of letter.

- Accordingly, Final Show Cause Notice u/S 17 was issued to the institution dated 20.12.2024. The institution has submitted a reply vide letter dated 22.01.2025 of Final Show Cause Notice u/s 17 after VT under Section 13 received in WRC office on 04.02.2025.
 - 12. AND WHEREAS, the matter was considered by WRC in its 425th Meeting held on 29th 30th May 2025 wherein the Committee decided as under:-

"The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

i. Initially, the institution was running in rented premises and it has not been shifted to its own premises. After submission of revised land documents on lease, inspection of the institution at the new premises has not been conducted.



- ii. The recognition granted to B.Ed. course with annual intake of 100 vide order dated 08.11.2009 has been withdrawn vide order dated 14.12.2020 and 14.08.2021 for nonfulfilment of NCTE Norms and Regulations related to own land and building and no reply to SCN received from the institution.
- iii. On the directions of the Hon'ble High Court of Delhi at New Delhi vide Order dated 10.09.2021, the institution was permitted counselling on admitting students for the academic session 2021-22 vide letter dated 05.10.2021.
- iv. On the decision of the Appeal Committee vide remand back Order dated 31.08.2023, restoration order dated 19.09.2023 was issued and Committee decided to conduct inspection u/s 13 of NCTE Act, 1993 to verify infrastructural and instructional facilities available in the institution and its related documents.
- v. On consideration of VT Report u/s 13 dated 02.05.2024, Show Cause Notice u/s 17 dated 03.07.2024 was issued to the institution followed by Final Show Cause Notice dated 20.12.2024 to comply the deficiencies mentioned therein. The reply of Final SCN was considered by the Committee and found that the institution is still deficient in light of NCTE Norms and Regulations on the following grounds:
- a. The institution has submitted the colour photocopy of CLU certificate dated 05.02.2021 signed by Patwari, Dist.- Pali, Rajasthan. Total built-up area mentioned as 2038 sqm. Total land area is not mentioned. As per VT remarks, the land is on private lease having total land area 1694.58 sq.mts. which less as per NCTE norms for 100 intake (two units) of B.Ed. course.
- b. The institution has not submitted the latest Non-Encumbrance Certificate and indicating the Khasra No. and total area of the land.
- c. The institution has submitted Building Plan signed/approved by PWD Engineer and Architect without showing date of approval. The same is not certified by Local Government. Khasra No. is not shown in the building plan.
- d. Submitted Fire Safety Certificate issued by Fire Chief Officer, Pali, Rajasthan vide letter No. Fire/2024/4192 dated 02.05.2024 having general mistakes in the Hindi language. No Khasra/Plot No. and total area of the land has been mentioned in the NOC. The institution has not submitted copy of online fire certificate issued by LSG portal of Govt. of Rajasthan.
- e. Submitted Building Completion Certificate with floor wise issued by Junior Engineer Municipal Corporation, Pali, Rajasthan signature without date. Total land area mentioned as 1694.58 sq. mtr. which is less against required 2500 sq.mts. and built-up area 2038.92 sq. mtr. date of construction in 2016. As per VT remarks dated 02.05.2024, one school is running on the same patch of land but in a separate building.
- f. With regard to point regarding the college campus lacks accessibility features viz. lift, ramp, divvying toilets (there is only one toilet in the entire 4-storied building of the college, the institution mentions that these facilities are under construction.

h. With regard to point raised that latest approved faculty list by the affiliating body needs to be provided, the institution submitted photocopy of faculty list comprising 01+15 faculties without approval of affiliating body. The faculty at Sl.no.1 namely Sh. Satya Prakash, Perspectives in Education is not having PG in Social Science or PG (M.A) degree in education as per NCTE norms.

In view of the above, Committee decided that the recognition of B.Ed. course of the institution be withdrawn u/s 17 (1) of NCTE Act, 1993 w.e.f. end of the academic session next following the date of issue of withdrawal order."

- 13. NOW THEREFORE, in exercise of the powers conferred under Section 17(1) of the NCTE Act, 1993, recognition granted for B.Ed. programme in respect of the institution viz. "Smt. Rukma Devi Mahila Shikshak Prashikshan Mahavidyalaya, Veer Durga Das Nagar, Pali, Rajasthan is hereby withdrawn from the end of the academic session next following the date of communication of the said withdrawal order.
- 14. Further, the institution and affiliating body are hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."

15. Further, if the institution is not satisfied with the Order, it may prefer an Appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
