RESTORATION ORDER

Whereas, recognition was granted to the institution, namely, Kriteeti B.Ed. College, (Run by Janjagruti Seva Samiti), Patanjali Society, Khodiyarnagar, N.H. No. 8, Ahmedabad, Gujarat - 382350 under section 14 of NCTE Act, 1993 for conducting **B.ED.** course with an annual intake of 100 students vide order no. WRC/5-6/102nd/2008/30542-30547 dt. 15.03.2008.

2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Kriteeti B.Ed. College, (Run by Janjagruti Seva Samiti), Patanjali Society, Khodiyarnagar, N.H. No. 8, Ahmedabad, Gujarat - 382350 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

3. And whereas, after the receipt of affidavit dt. 19.01.2015 from the institution, a revised recognition order no. WRC/APW04437/323435/2015/145646 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

4. And Whereas, the matter was placed before the WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 08.08.2016.

5. And whereas, reply dt. 22.09.2016 was placed before the WRC in its 276th meeting held on May 30-31, 2017 and the Committee decided as follows:-

"The case file was seen. In response to the Show Cause Notice issued on 08/08/2016, the institution vide letter dt. 28/09/2016 has submitted various documents. The institution has requested to run only 1 basic unit of 50 students.

However, the following deficiencies are seen:-

- The institution has not submitted list of staff members duly approved by the affiliating body.*
- The latest Building Completion Certificate approved by the competent authority (RES/Govt. Engineer) has not been submitted.*

Compliance in this matter should be submitted within 1 month failing which action will be taken under section 17 of the NCTE Act, 1993."

6. And Whereas, a conveyed letter no. WRC/323435/B.Ed./Guj./2017/186461 dt. 05.06.2017 was issued to the institution.

7. And whereas, institution had not submitted any reply in response to conveyed letter dt. 05.06.2017 and the matter was placed before the WRC in its 278th meeting held on July 25-26, 2017 and the Committee decided as follows :-

The case file was seen. Show cause notice was issued to the institution on 05.06.2017.

The institute has not replied till date. Recognition is withdrawn from the session 2018-2019. FDRs, if any, be returned."

8. And Whereas, a withdrawal order no. WRC/APW04437/323435/Guj./278th/2017/188178 dt.07.08.2017 was issued to the institution.

9. And Whereas, the institution has filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"after perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the W.R.C. for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously."

The Council hereby remands back the case of Kriteeti B.Ed. College, Patanjali Society, Khodiyar Nagar, Ahmedabad Corpn., Gujarat to the WRC, NCTE, for necessary action as indicated above."

10. And Whereas, reply dt. 26.09.2018 of institution was placed before the WRC in its 299th meeting held on October, 30 – November 1, 2018, and Committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously."

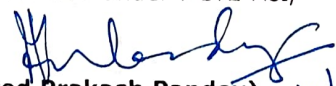
On perusal of the reply dated 26.09.2018, the Committee observed that:-

- (i) The institution has submitted the approved staff list of 1+9 faculty members.*
- (ii) FDR for Rs.12.00 lakhs in original as required under clause 10(1) of NCTE Regulations, 2014 submitted.*

Hence, the Committee decided that Recognition of the institution be restored for one unit of B.Ed. course."

11. Now Therefore, this restoration order is issued as per decision of the WRC in its 299th meeting as cited above.

12. Contravention of any of the provisions of the NCTE Act, 1993, NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution. as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
