Whereas recognition was granted to the institute **SOMNATH EDUCATION AND CHARITABLE TRUST, C/O SHIVAM SILK PALACE, OPP. GOVERNMENT HOSPITAL, AT - KODINAR JUNAGADH 362720 GUJARAT** under section 14 of NCTE Act, 1993 for conducting P.T.C. course with an intake of 50 from the academic session 2006-2007 vide order No.WRC/5-6/88/2006/C-11176 dated 27.02.2007.

2. Whereas on the basis of complaint received against institution, the Western Regional Committee had constituted a visiting team u/s 17 of NCTE Act, 1993 to visit the institution.

3. And whereas, the matter was considered by the WRC in its 128th meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. Land documents certified by the competent authority to be submitted.
2. Certified copy of the approved building plan to be submitted.
3. Certified copy of the CLU to be submitted
4. List of books in the library with accession numbers to be submitted.
5. Affidavit by the management w.r.t. appointment of staff to be submitted.
6. Affidavit from individual staff members in the prescribed format to be submitted.

4. And whereas the WRC directed that an opportunity be given the institution to make a written representation within 15 days of the receipt of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a clarification was issued to the institution on 05.01.2010.

5. And whereas the matter was again considered by the Committee in its 131st meeting held on February 24-25, 2010 and having taken into consideration the reply submitted by the institution and all the relevant facts of the case, it was decided to withdrawn recognition for conducting P.T.C course.

6. Now, therefore recognition to **SOMNATH EDUCATION AND CHARITABLE TRUST, C/O SHIVAM SILK PALACE, OPP. GOVERNMENT HOSPITAL, AT - KODINAR JUNAGADH 362720 GUJARAT** in terms of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the end of the academic session next to the following date of this withdrawal order on the following grounds.

1. Certified copy of land document has not been submitted.
2. Staff affidavit by the management not submitted.
3. Principal does not have adequate teaching experience as per the NCTE norms.

7. Affiliating Body/ State Govt. are advises not to admit/ allot any student in P.T.C. in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1- Bahadur Shah Zafar Marg, Near RTO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
