ORDER

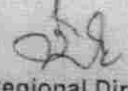
And whereas, the recognition was withdrawn vide order No. No.WRC/APW02158/322239/131st/2010/65809 dt. 10.03.2010 as per decision of 131st meeting of WRC.

And whereas, the Visiting Team was constituted for inspection as per the direction of Appeal Committee NCTE New Delhi order No. F.No. 89-367/2010-Appeal dt. 26.04.2011.

And whereas, the inspection of the institution was conducted on 23.07.2011. The visiting team report was placed in 154th meeting of WRC and the Committee decided to issue show cause notice under Section 17(1) of the NCTE Act, 1993.

And whereas, the reply submitted by the institution in response to show cause notice was placed in 157th meeting of WRC held on 8th-9th, December, 2011 and the Committee decided to continue the recognition of the said institution with same terms and conditions as mentioned in the recognition order dt. 27.02.2007.

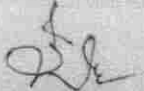
