Withdrawal Order U/S-17 437, 438, 439, 440

Whereas, recognition was granted to the institution, namely, PREMWATI COLLEGE OF EDUCATION, 637,WRIGHT TOWN DISTRICT.- JABALPUR, - 482002, MADHYA PRADESH (APW06227/223686) for B:Ed. Course 100 Intake vide order dated 28.08.2008.

AND WHEREAS, Shri Dayaram Choudhry filed W.P. No.6094/2014. (PHL) in the Hon'ble High Court at Jabalput. The said W.P. was clubbed with the PHL filed by Shri Pawan Dubey, wherein the Hon'ble court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by the NCTE Hqrs.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 27.01.2016.

AND WHEREAS, Revised Recognition order was issued to the institution on 10.02.2016.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 21.02.2015.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 27.07.2015. The institution reply was not submitted.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 28.09.2016.

AND WHEREAS, the matter was placed in 260th Meeting held on October 13-15, 2016 of WRC and the Committee decided that "... Deficiency letter was issued on 27/07/2015. However no reply has been received so far.

- You are directed to explain as to why the institution has contravened the NCTE Regulations by shifting to a new premises without submitting application along with the prescribed fee to the WRC and without obtaining its prior approval.
- You are directed to explain as to why the institution pays only consolidated salary of Rs 8000/- to lecturers and Rs. 12500/- to the Principal.
- The institution shall be re-inspected at the new premises provided the WRC accords permission for shifting to new premises.
- You are advised to submit application for NAAC assessment during the session 2015-2016 provided the WRC grants permission for shifting to new premises.

Hence, Show Cause Notice be issued on the points of Deficiency letter. Reply should be submitted to the WRO within 15 days."

AND, WHEREAS, the Show Cause Notice was issued to the institution on 19.10.2016 and the reply of SCN was not received.

AND WHEREAS, the matter was placed in 280th Meeting held on August 31st - September 01st, 2017 of WRC and the Committee decided that "... Deficiency letter was issued to the institution on 2017 of the institution of 27.07.2015. No reply has been received. Thereafter, show cause notice was issued on 19.10.2016. Reply has not been received till date.

Hence, Recognition is withdrawn from the session 2018-2019.

FDR, if any, be returned."

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadur Shah Zafar Marg, Near &TO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
