RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely, PREMIWATI COLLEGE OF LDUCATION, 637, WRIGHT TOWN, JABALPUR-482002, MADHYA PRADESH under section 14 of NCTE students.

AND WHEREAS, Shri Dayaram Choudhry filed W.P. No.6094/2014. (PIL) in the Hon ble High Court at Jabalpur. The said W.P. was clubbed with the PIL filed by Shri Pawan Dubey, wherein the Hon ble court had directed to conduct inspection of all B.Ed. institutions. The inspection of the institution was conducted u/s 13 by

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs, on 21.02,2015.

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 27.01-2016.

AND WHEREAS. Revised Recognition order was issued for two basic units (50 students each) to the institution on 10.02.2016.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs, to the institution on 27,07,2015. The institution reply was not submitted.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTL Hqrs. in WRO on 18.09,2016.

AND WHEREAS, the matter was placed in 260th meeting of WRC held on October 13-15, 2016 and the Committee decided that "... Deficiency letter was issued on 27/07/2015. However no reply has been received so far.

Hence, Show Cause Notice be issued on the points of Deficiency letter. Reply should be submitted to the WRO within 15 days."

AND, WHEREAS, the Show Cause Notice was issued to the institution on 19,10,2016 and the reply of SCN was not submitted.

AND WHEREAS, the matter was placed in **280<sup>th</sup>** meeting of WRC held on August 31<sup>st</sup> - September 61<sup>st</sup>, 2017 and the Committee decided that "... Deficiency letter was issued to the institution on 27.07.2015.No reply has been received. Thereafter, show cause notice was issued on 19.10.2016. Reply has not been received till date.

Hence, Recognition is withdrawn from the session 2018-2019. FDR, if any, be returned."

AND WHEREAS, the Withdrawal Order issued on 08.09.2017. The institution filed a appeal to the appellate authority. Hqrs. no. APPL12017. dated 28.10.2017. Regulatory file sent to Hqrs. on 19.12.2617.

AND WHEREAS. Appeal order dated 13-02-2018, Decision Direction of the Appellate Authority. The committee, concluded that the appeal deserves to be remanded to WRC with a direction to reissue their Show Cause Notice dt. 19.10.2016 to the appellant for replying and take further action as per the NCH Regulations, 2014, in the meanwhile, the order of withdrawal shall be kept in abayance.

NOW THEREFORE, the Council hereby remands back the case of Premwati College of Education, 637, Wright Town, Jabalpur-482002, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above.

AND WHEREAS, the matter was placed in 292nd meeting of WRC held on May 15-17, 2018 and the Committee decided that "... This is a case of appeal. Appellate Authority vide order dated 13.02,2018 has remainded the case to WRC.As directed by the Appeal Committee, Show Cause Notice be re-issued."

AND, WHEREAS, the Show Cause Notice was issued to the institution on 21.05,2018 and the reply of SCN was received on 13.06.2018.

AND WHEREAS, the matter was placed in 294th Meeting held on July 04 - 05, 2018 of WRC and the Committee decided that "... Consequent to the appeal order. Show Cause Notice dated 21.05.2018 was issued to the institution regarding shifting of the institution without the permission of the WRC.

The institution has submitted Rs.50,000/- as fee for shifting. The fee for shifting as per NCTE Regulations, 2014 is Rs.1.50 lakhs.

As soon as the additional fee of Rs.1.00 lakhs, VT be constituted.

Since this is a case of shifting and the shifting process is in progress, the recognition of the institution is restored."

NOW THEREFORE, the recognition of PREMWATI COLLEGE OF EDUCATION, 637, WRIGHT TOWN, JABALPUR-482002, MADHYA PRADESH for conducting B.Ed. course with an annual intake of 100 students (two basic units of 50 students each) is herby revived.
