Whereas recognition was granted to the institute SHREE RAM ADHYAPAN MANDIR. (AMARBHARTI TRUST SANCHLIT), TAL-DEHGAM, TA. MANSA, GANDHINAGAR-382305, (AMAROH under section 14 of NCTE Act, 1993 for conducting PTC course vide order No.WRC/5-/89/2006/ dt. GUJARA from the academic session 2006-2007 with an annual intake of 50 students.

- Whereas on the basis of complaint received against institution, The Western Regional Committee had constituted a Visiting Team u/s 17 of NCTE Act, 1993 to Visit the institution.
- AND WHEREAS, THE inspection of the institution was conducted on 30.01.2009 3.
- And whereas, the matter was considered by the WRC in its 117th meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-
 - 1. Classroom size not adequate.
 - 2. Science & Psychology lab. are in the same room.
 - 3. Salary paid in cash.
- And whereas, the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 29/04/2009.
- And whereas, the matter was again considered by the Committee in its 121st meeting held on July 8-9, 2009 and having taken into consideration all the relevant facts of the case, it was decided to withdrawn recognition for conducting PTC course.
- Now, therefore recognition to SHREE RAM ADHYAPAN MANDIR, (AMARBHARTI TRUST SANCHLIT), TAL-DEHGAM, TA. MANSA, GANDHINAGAR-382305, GUJARAT in terms of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the end of the academic session next to the following date of this withdrawal order on the following grounds.
 - 1. Deficiencies mentioned in the show cause notice not removed.
- Affiliating Body/ State Govt. are advises not to admit/ allot any student in PTC in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.
